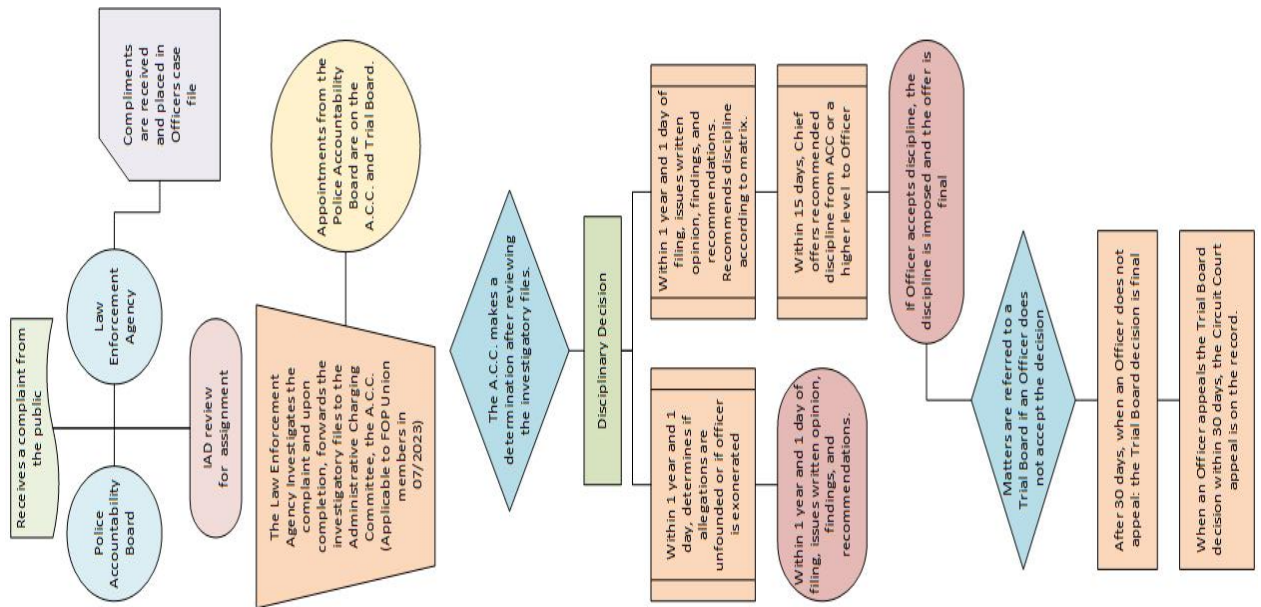

COMPLIMENT AND COMPLAINT FORM



The Montgomery County Police Department (MCPD) strives to provide the highest quality of policing and public safety services to all members of the public. In the performance of their duties, MCPD employees come in contact with hundreds of thousands of people each year. Contact with members of the public by MCPD employees, be it in person, over the phone, or via written correspondence, occurs for a variety of reasons. At all times, MCPD employees are expected to perform their duties and conduct themselves in a respectful, unbiased, and professional manner. The police department encourages members of the public to file a complaint when they believe an MCPD employee (either a sworn police officer or a non-sworn civilian staff member) has acted in a manner that is not consistent with departmental policy, or county, state, or federal law. This form can be used to document a complaint and initiate an administrative review. Please refer to the noted instructions regarding the completion and submission of this form. Compliments, although not necessary, can also be documented on this form to advise of noteworthy actions and/or outstanding performance by MCPD employees. MCPD remains accountable to the public it serves, as well as the people it employs, and therefore welcomes feedback from anyone who wishes to let us know how we are doing and where we can improve.

Instructions:

1. Fill out form. (For TTY/TDD users, please dial MD Relay, 7-1-1)
2. Complaints alleging excessive force must be filed with the Montgomery County Police Department or Police Accountability Board within 366 days of the incident.

4. Compliments/Complaints may be mailed by printing out this form, completing it, and mailing to the address located on the back of these instructions.
