Mission is to prevent, ease and end homelessness in our community. Bethesda Cares are strong supporters of the "Housing First" movement, an alternative to the traditional shelter system. Through Housing First, an approach now considered a nationwide best practice, they place people, regardless of their physical or mental challenges, into permanent housing. They then bring supportive services to them, helping them cope with their issues from that stable platform. They believe coping with such challenges are not precursors to housing; rather, they will flow from the safety and stability that comes from having a permanent home in the first place.

Easing Homelessness - Onsite Services: Their main office serves as both a Drop-In Center for clients experiencing homelessness and the site for most of their services. For persons experiencing homelessness, their Drop-In Center offers hot coffee, snacks and a place that clients can come in for a respite from the weather. Importantly, it's also a place where they know they will be greeted with smiles, and not be asked to "move along." Their drop-in also provides a workstation for their street outreach worker and direct services staff, who work closely together to raise the level of care for persons experiencing homelessness. Their drop-in services are reserved for persons experiencing homelessness, with a clothing closet resource, client phone, and toiletries, and temporary mail services until the client obtains their own housing placement in the community.

Preventing Homelessness – Housing Stabilization: Through their Housing Stabilization Program (eviction/utility shutoff prevention), they assist county wide keeping area residents safe in their homes with utilities turned on. Collaborating with a large network of local providers who, they partner to package grant assistance to County residents under severe financial distress. Our Housing Stabilization Counselor counselor reviews the request for a plan to maintain housing once the client comes through the crisis; if approved, our grants are sent directly to the appropriate landlord/utility company. A safety-net program, this assistance is available once per year from time of last receipt of a grant.

Ending Homelessness - Outreach Team: The Outreach Team is available at the Drop-In Center, Monday through Friday, to discuss clients' needs and assist with referrals. Additionally, the Outreach Team reaches out to clients where they are located: in parks, Metro stops, parking garages. Whatever the client's needs, they work to form individual strategies to help each client to exit homelessness. As they engage with clients, building trusting relationships with them, they offer food, clothing, access to a staff psychiatrist.

Hours: 8am to 4:30pm, Monday through Friday. Offer employment opportunities for at-risk and homeless veterans with physical, psychiatric, and substance abuse problems. The VA works with private industries as well as the public sector to find work for these veterans, where they will have the opportunity to learn new job skills, relearn successful work habits, and regain self-esteem. In conjunction with the Work Therapy program, the VA operates more than 50 community-based transitional residences with more than 432 beds. Homeless veterans stay in the housing an average of six months while they gain work skills.



Program provides transitional housing, on-site case management, food, clothing, transportation, childcare subsidy/assistance, employment support and other essential supportive services to homeless women Veterans and their children. The program focuses on integrating women veterans back into their local communities and providing vast, safe and suitable residential areas to choose from. The program is a collaboration with our resource partners that includes targeted supportive services to assist women veterans in reaching their goals. Also assist with permanent placement once veterans are ready to transition from residential facilities. The S.A.F.E. program helps to prevent homelessness by providing emergency financial assistance. Program recipients also receive resources on saving, budgeting and living on a fixed income. S.A.F.E. eases financial hardships by providing assistance with past due rent, new lease deposit and utility assistance. The program is open to women Veterans and members of the U.S. Military Reserve and Guard component forces, regardless of their location.

Homeless Veteran Program Coordinators provide outreach, case management, referrals to benefits counselors, linkage to health care, and housing assistance. Homeless veterans in need of assistance after hours should contact their local VA Medical Center's emergency room.

Domiciliary Care for Homeless Veterans (DCHV) Program provides residential rehabilitation and treatment services for Veterans with multiple and severe medical conditions, mental illness, addiction, or psychosocial deficits. Identifies and addresses goals of rehabilitation, recovery, health maintenance, improved quality of life, and community integration in addition to specific treatment of medical conditions, mental illnesses, addictive disorders, and homelessness. The residential component emphasizes incorporation of clinical treatment gains into a lifestyle of self-care and personal responsibility.

HUD-VASH Supported Housing Program is a joint program with the U.S. Department of Housing and Urban Development (HUD). The program provides permanent housing and ongoing case management treatment services for homeless veterans who would not be able to live independently without the support of case management. HUD's Section 8 Voucher Program has designated over 10,000 vouchers to Public Housing Authorities (PHAs) throughout the country for veterans who are homeless.

Supported Housing Program provides ongoing case management services to homeless veterans. Emphasis is placed on helping veterans find permanent housing and providing clinical support needed to keep veterans in permanent housing.

Drop-In Centers provide a daytime sanctuary where homeless veterans can clean up, wash their clothes, and participate in a variety of therapeutic and rehabilitative activities. Linkages with longer-term assistance are also available.

VBA-VHA Special Outreach and Benefits Assistance staff provide dedicated outreach, benefits counseling, referral, and additional assistance to eligible veterans applying for VA benefits.

Veterans must show proof of service. The center provides benefits counseling and assistance with navigating the VA and paperwork, as well as employment counseling, counseling on PTSD and sub-PTSD, substance abuse counseling, family and marital counseling, psychological counseling related to readjustment, coordination and referral with doctors, employment related issues, assistance with basic needs such as food, shelter and clothing, medical and legal referrals, homeless assistance and will work with Montgomery County to find shelter placement, sexual trauma counseling, community outreach, bereavement counseling, and more. All services are provided at no cost to the veteran and their family. Veterans do not need to be enrolled with the Department of Veteran Affairs Medical Centers to use the Vet Center. Veterans do not need a disability rating or service connection for injuries from either the Department of Veteran Affairs or the Department of Defense, to use the Vet Center. View <u>Vet Center Eligibility Criteria</u>. If you live outside of Montgomery County <u>view a list of other locations</u> that may be closer to you. **Directions:** The Silver Spring Vet Center is located near the intersection of Seminary Road/Capitol View Avenue. You can also take the #5 Ride On Bus from either the Silver Spring Metro Station or the Twinbrook Metro Station and be dropped off at the Capitol View Avenue stop.
