1. Minutes of March 28, 2018, Worksession.

Action: <u>Approved</u>, (ESR/BG, 4-0) (JHP-abstained).

2. A-6534, Petition of Neal and Beth Atwell (Variance). Letter to the Board from the Petitioners submitting a revised location drawing for their garage.

Action: <u>Re-opened the record to receive the revised location drawing for</u> their garage, (BG/ESR, 5-0).

3. CBA-1801, Petition of Potomac Holdings, LLC. (Automobile Filling Station). Letter to the Board from Nancy P. Regelin, Esquire requesting a one year extension of time to implement the modification to this special exception.

Action: <u>Granted one year extension of time to implement the modification of this special exception, (KF/ESR, 5-0).</u>

4. CBA-2740 and CBA-2740-A, Petition of Mid-Atlantic Petroleum Properties (Automobile Filling Station). 7. S-823, Petition of Murray Poltz and Richard Miller (Medical Practitioner's Office for use of other than a Resident of the Building). Letter to the Board from Cathy G. Borten, appealing the Hearing Examiner's decision in CU-T-17-01, and requesting oral argument in both that case and in related case S-596. Also included is a letter from Steve Mister, President, East Gate Recreation Association, Inc., supporting the request for oral argument in both cases. Also included is a letter from William J. Chen, Jr., Esquire, requesting that the Board deny the request for oral argument and adopt the Hearing Examiner's decision and recommendation in these cases, and raising an additional issue for oral argument if it is granted. Also included is a letter from Cheryl A. Wetter, opposing request for oral argument and requesting to speak if it is granted. Also included is a letter from Susanne M. Lee, Vice President, West Montgomery County Citizens Association, opposing the request for oral argument. Also included is a Report and Recommendation from the Hearing Examiner in case S-596, dated March 7, 2018, recommending the denial of the requested administrative modification as moot, in light of the denial of the proposed telecommunications tower in CU-T-17-01.

Action: <u>Denied the request for oral argument in both cases, and adopted the</u> <u>Hearing Examiner's decisions denying the conditional use and dismissing the</u> <u>administrative modification as moot, (ESR/SBB, 5-0).</u>
