#### **WORKSESSION MINUTES**

Wednesday, December 8, 2021

### **ACTION ITEMS:**

1. Minutes of November 17, 2021, Worksession.

Action: Approved, (BG/RM, 5-0).

2. A-6703, Petition of Daniel Hart and Monica Lee (Variance). Appeal received from John Jester, asserting that at the October 20, 2021, Worksession, the Board should have approved his request for reconsideration, and the original denial of this variance should have been upheld. Because appeals must be filed with the Circuit Court, the Board will treat this as a request for reconsideration of its November 3, 2021, Resolution to Deny Request for Reconsideration, issued pursuant to its October 20, 2021. Worksession.

Action: Denied the Request for Reconsideration, (JHP/BG, 5-0).

**3. A-6715, Petition of Walter C. Jones.** (Variance). Email letter to the Board from the Petitioner, requesting revision of the Board's previously granted variance decision. *Located at 11501 Nairn Farmhouse Court, Silver Spring, Maryland.* 

Action: Re-opened the record to receive the revised site plan, and revised the granted variance, (JHP/RM, 5-0).
