Major Issue: The FY10 Recommended budget shows a net decrease of 3.5 workyears for the County Attorney's Office. Given that some caseloads have increased, the County Attorney's Office should discuss whether this reduction will impact operations in the upcoming year.

The Executive's recommendation for the County Attorney's Office is attached at ©1-6.

Overview

For FY10, the Executive recommends total expenditures of \$5,250,100 for the Office of the County Attorney, a reduction of \$430,760 or 7.6% less than the FY09 approved budget.

FY10 Expenditure Issues

Personnel Changes: The Executive recommends a net reduction of 3.5 workyears in the FY10 budget. The changes by division are listed in the table below. *The Committee may want to ask the County Attorney's Office what impact, if any, this reduction in staff will have on operations over the next fiscal year.* In particular, it seems as if certain types of caseloads are

increasing due to declining economic conditions, such as the 40% increase in Child in Need of Assistance petitions noted by the County Attorney's Office during FY09. *Does the County Attorney's Office expect other economy-driven impacts on its caseload in other areas? Has it aligned its personnel complement in FY10 to meet these needs?*

Changes by Division:

Insurance Defense Litigation: This section provides legal defense for cases involving the county, 14 local government participants, and all of their employees. Cases involve litigation in areas such as common law torts, police civil rights claims, workers' compensation claims, Americans with Disabilities Act, Individuals with Disabilities Education Act, and employment discrimination.

Decrease Cost: Annualization of FY09 Personnel Costs (-\$160,420)

This item is decreasing because of an increase in personnel costs due to turnover. No workyears are affected.

Increase Cost: Miscellaneous Adjustments (\$50,210)

This item reflects various personnel items, such as changes in benefits elections, staff, turnover, and other compensation and benefit cost changes affecting more than one program. This is the amount proportionately assigned to the Insurance Defense Litigation Unit.

Health and Human Services: This division acts as counsel and gives legal advice to the Department of Health and Human Services. The attorneys also represent Child Welfare Services in Juvenile Court in cases involving child abuse and child neglect.

Increase Cost: Miscellaneous Adjustments (\$27,330)

This change reflects the addition of 0.3 workyears transferred to the division. A County Government Aide position was split into 3 part-time positions, and one position was placed in this division because of need.

Increase in Child in Need of Assistance (CINA) Petitions

The County Attorney's Office states it has seen a significant increase in calls for screening and new investigations of child abuse and neglect. As a result, the number of new CINA petitions for abuse and neglect has risen as well. The County Attorney's Office states it has seen a 40% increase in new CINA petitions filed, and a 20% increase in the number of hearings during the first eight months of FY09. *While the FY10 CE Recommended Budget does add a part-time Aide position to this division, the Committee may want to ask the County Attorney's Office how it has dealt with this significant increase in cases and whether it has sufficient staff to handle the workload into FY10.*

Finance and Procurement: This division acts as counsel and gives legal advice to the County Executive, Council, and various departments, agencies, boards, and commissions regarding tax and procurement matters.

Shift: Assistant County Attorney III to the Capital Improvements Program (CIP) in the Department of General Services (DGS) (-\$140,8490)

This change shifts funding to DGS, because the incumbent is performing CIP-related legal work for DGS.

Decrease Cost: Miscellaneous Adjustments (-\$27,570)

The cost reduction is the net effect of department-wide compensation and benefit changes as well as the addition of one workyear. This workyear was shifted from the Human Resources and Appeals Division.

Human Resources and Appeals: This division acts as counsel and gives legal advice to the following agencies: Fire and Rescue Service, Ethics Commission, Board of Investment Trustees, Office of Human Resources, Corrections, Office of Public Information, Transportation, Human Rights Commission, Board of Appeals, and the Police Department.

Increase Cost: Miscellaneous Adjustments (\$69,640)

This cost increase is the net effect of department-wide compensation and benefit changes as well as the reduction of one workyear, which was moved to the Finance and Procurement Division.

Zoning, Land Use, and Economic Development: This division represents and advises the County Executive, Council, and various departments with respect to land acquisitions and real estate transactions. It also advises them on telecommunications and cable matters.

Increase: Miscellaneous Adjustments (\$29,010)

This increase is the net effect of this division's share of department-wide compensation and benefit changes, as well as the net change of workyears assigned to the division. The 0.5 workyear increase reflects a transfer of one workyear from the Public Interest Division, and the reduction of a one-workyear position to a 0.5-workyear position.

Public Interest Litigation: This division provides litigation and other legal services to County agencies and departments. It is primarily responsible for processing and prosecution of code enforcement violations from all departments and agencies that have been referred to the County Attorney, including past due real property taxes, personal property taxes, code enforcement judgments, subrogation claims, bounced checks, unpaid fines, and other amounts billed by the County.

Debt Collection

The Collection Unit has collected \$21.1 million in deposits through March 31, 2009. The County Attorney's Office attributes this increase to the fact that it is seeking out big dollar cases and making a more dedicated effort to contacting them through phone and/or e-mail. The County Attorney's Office has also been proactive in its efforts to file suit against delinquent accounts in a timelier manner. The projected collections total for FY09 is \$26 million. If realized, this would be a 9% increase over FY08 collections, which totaled \$23.8 million. *The Committee may want to ask the County Attorney's Office to elaborate on its debt collection operations and its plans for the upcoming year.*

Decrease Cost: Retirement Incentive Program (RIP) Savings (-\$20,330)

This savings reflects an Assistant County Attorney III who took the retirement buy-out in FY09.

Decrease Cost: Part-time Assistant County Attorney III (-\$49,930)

This item reflects a lapsed position.

Decrease Cost: Lapse Assistant County Attorney III (-\$147,360)

This change is a lapse of the ACAIII position that retired in FY09. The position is currently vacant.

Decrease Cost: Miscellaneous Adjustments (-\$180,370)

This change accounts for this division's share of department-wide changes in compensation and benefits.

Support Services: This division provides administrative, research, and technical guidance and support to the other divisions within the Department.

Decrease Cost: Miscellaneous Adjustments (-\$233,680)

This change accounts for the division's share of department-wide changes in compensation and benefits, as well as the net change in workyears. Two 1.0-workyear positions were transferred into the Administration Division, while one 0.2-workyear position was added.

Administration: This division provides internal personnel, financial, and operational management for the County Attorney's Office.

Increase Costs: Various Personnel and Operating Changes (\$112,000)

These increased costs represent compensation and operating changes such as service increments, retirement adjustments, annualization of FY09 operating expenses, and printing and mail adjustments.

Decrease Cost: Abolish Principal Administrative Aide (-\$58,320)

This item abolishes a PAA position. The incumbent will be transferred to a vacant position in FY10.

Increase Cost: Miscellaneous Adjustments (\$299,870)

This change reflects the division's share of department-wide changes in compensation and benefits, and the addition of two workyears transferred from the Support Services division.

FY10 Revenue Issues

County Attorney revenues are projected to decrease by 8.7% in FY10. This decrease stems from a reduction in the amount paid by the Revenue Authority for the reimbursement of legal services.

Council Staff Recommendation

Council staff supports the recommended FY10 budget as submitted by the Executive.

MISSION STATEMENT

The mission of the Office of the County Attorney is to act as the chief legal officer of Montgomery County government and to conduct all its legal business.

BUDGET OVERVIEW

The total recommended FY10 Operating Budget for the Office of the County Attorney is \$5,250,100, a decrease of \$430,760 or 7.6 percent from the FY09 Approved Budget of \$5,680,860. Personnel Costs comprise 90.0 percent of the budget for 72 full-time positions and three part-time positions for 39.3 workyears. Operating Expenses account for the remaining 10.0 percent of the FY10 budget.

ACCOMPLISHMENTS AND INITIATIVES

- ❖ *Through January 2009, the Collection Unit has registered \$17.6 million in net deposits from debts owed to the County. This already exceeds the forecasted amount of \$8 million for all of FY09. The increase in funds collected can be directly associated to greater efficiencies within the Unit.*
- ❖ *Installed the first County on-line check deposit scanning workstation with the help of PNC Bank. The Debt Collection Unit is now able to deposit checks via the new scanning device and transmit funds electronically to PNC Bank. This avoids delays in check deposits.*
- ❖ *Productivity Improvements*
 - *In FY07, the office purchased a work management system to replace the database used for the attorneys' calendars and work schedules. In FY10, changes to the user interface will be made to facilitate accurate data collection on case disposition and close-out and to add customized reports.*
 - *Until recently, the Office of the County Attorney utilized a pool system to provide secretarial support to the attorneys outside of the HHS Division. Based on a widespread recognition that this system led to underutilization of secretarial resources, the pool system was dismantled and attorneys are now assigned a specific secretary. The new assignment system has been generally successful and well-received by the attorneys.*

PROGRAM DESCRIPTIONS

Insurance Defense Litigation

Provides legal defense for cases involving Montgomery County and fourteen local government Self-Insurance Fund participants (including such entities as the Montgomery County Board of Education, City of Rockville, Maryland-National Capital Park and Planning Commission, Montgomery College and the Housing Opportunities Commission) and all of their employees. The attorneys appear regularly before State and Federal courts in Maryland and the District of Columbia for trials and oral arguments and before the Workers' Compensation Commission. These cases involve litigation in the following areas: common law torts; Police civil rights claims; Other Federal and State civil rights - constitutional torts; Americans with Disabilities Act; Individuals with Disabilities Education Act; Workers' Compensation; and employment discrimination.

Public Interest Litigation

The Division provides litigation and other legal services to County agencies and departments in support of their mission to promote general welfare and protect vulnerable citizens. The Division acts as counsel and gives legal advice to the Police Department, the Departments of Emergency Management and Homeland Security, Environmental Protection, Permitting Services, Consumer Affairs,

and Recreation. It also provides counsel to the Office of Landlord and Tenant Affairs, the Historic Preservation Commission, and the Inspector General's Office. The program represents these entities in contested cases before County Board of Appeals and in both State and Federal courts. The program also drafts and reviews agreements, legislation, regulations and other legal documents. Attorneys from the program conduct negotiations, issue legal opinions, and testify before public bodies. It is primarily responsible for the processing and prosecution of code enforcement violations from all departments, agencies, boards and commissions which presented in the District Court of Maryland. The Debt Litigation or Collection Unit collects all monies owed to Montgomery County that have been referred to the County Attorney, including past due real property taxes, personal property taxes, code enforcement judgments, subrogation claims, bounced checks, unpaid fines, and miscellaneous amounts billed by the County.


