**ADULT PUBLIC GUARDIANSHIP REVIEW BOARD**

- Created -- Maryland Annotated Code, Family Law, Section 14-402 (a), as amended in 1993. Bill No. 7-95, effective 7/11/95, re: Department of Health and Human Services reorganization.
- Purpose -- Responsible for reviewing each public guardianship at least twice a year.
- Membership -- 11 members - a professional from the Department of Health and Human Services; two physicians, including one psychiatrist from the Department of Health and Human Services; a representative of the Commission on Aging, a professional from a local non-profit social service organization, a public health nurse; a lawyer; a professional in the field of disabilities; and a person with a physical disability. There are also two laypersons from the public-at-large.
- Terms -- Three-year terms - no compensation.
- Meetings -- First Tuesday of each month from 1:00 p.m. - 3:00 p.m.




#### Leggett Seeks Applicants for Adult Public Guardianship Review Board

County Executive Isiah Leggett is seeking applicants to fill two vacancies on the Adult Public Guardianship Review Board for a person with a physical disability and a lay individual.

The eleven-member board is responsible for reviewing each adult public guardianship at least twice a year. Members serve three-year terms without compensation, and meet the third Tuesday of each month from 1 to 4 p.m.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply, and should write by November 14 to County Executive Isiah Leggett at the Executive Office Building, 101 Monroe Street, Rockville, MD 20850 or send an e-mail to [countyexecutive.boards@montgomerycountymd.gov](mailto:countyexecutive.boards@montgomerycountymd.gov). A brief resume, including home and work phone numbers, should be included.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Members of this Board are eligible for reimbursement for travel and dependent care for meetings attended. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
