

#### **Leggett Seeks Applicants for Commission on Juvenile Justice**

County Executive Isiah Leggett is currently seeking applicants to fill five vacancies on the Commission on Juvenile Justice. Three of the vacancies are for partial terms.

The commission monitors the juvenile justice system and advises the County Executive, County Council and Juvenile Court on matters concerning juveniles. It is responsible for keeping both legislators and citizens informed about juvenile needs.

The commission is also responsible for promoting the general welfare of juveniles under the jurisdiction of the court; making budget recommendations affecting juvenile justice programs; and making periodic visits to facilities in the State that serve County juveniles. Members serve three-year terms without compensation. Meetings are held the third Tuesday evening of each month at the Council Office Building in Rockville.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply, and should write by November 3 to County Executive Isiah Leggett at the Executive Office Building, 101 Monroe St., Rockville, MD 20850 or send an e-mail to [CountyExecutive.Boards@montgomerycountymd.gov](mailto:CountyExecutive.Boards@montgomerycountymd.gov). A brief resume, with work and home phone numbers and e-mail address should be included.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Members of this committee are eligible for reimbursement for travel and dependent care for meetings attended. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
