## BOARD OF SOCIAL SERVICES

- Created -- Maryland Code Article 88-A, Section 14 and Montgomery County Code Sec. 37-8. Bill No. 7-95, effective 7/11/95 re: Department of Health and Human Services Reorganization.
- Purpose -- Duties include, but are not limited to: selection of the local Director, Montgomery County Department of Health and Human Services, from the state's merit system list; advising local Director and state Director regarding the local application of state policies or procedures; keeping well informed on local departmental activities, communicating to the residents broad and comprehensive information as to the objectives, policies, programs, and problems of local social services and public assistance administration.
- Membership - Thirteen members; one must be a member of the County Council.
- Financial Disclosure -- Confidential disclosure is not required.
- Terms -- Three years - no compensation.
- Meetings -- At least 9 times per year. Currently meeting on the first Monday of each month.



### Leggett Seeks Applicants for Board of Social Services

County Executive Isiah Leggett is seeking applicants to fill one vacancy on the Montgomery County Board of Social Services for a partial term ending in June 2010.

The thirteen member board advises the Department of Health and Human Services, the County Executive and County Council, as well as the Social Services Officer on the local application of state policies and procedures, receives briefings on local department activities, and communicates to the residents broad and comprehensive information as to the objectives, policies, programs and problems of local social services and public assistance administration in the County.

Members serve three-year terms without compensation and meet the first Monday of each month at 7:00 p.m. in Rockville.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply, and should write by November 28, to County Executive Isiah Leggett at the Executive Office Building, 101 Monroe St., Rockville, MD 20850, or send an e-mail to [countyexecutive.boards@montgomerycountymd.gov](mailto:countyexecutive.boards@montgomerycountymd.gov). A resume with home and work telephone numbers should be included.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Members of this Board are eligible for reimbursement for travel and dependent care for meetings attended. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
