SUBJECT: **Action**—supplemental appropriation to the FY09 Operating Budget, Department of Transportation and Department of General Services: snow removal/wind and rain storm clean-up, \$9,256,540 (source: General Fund)

On May 19 the County Executive requested approval of a supplemental appropriation request of \$9,256,540 for the following items:

- \$6,645,090 to cover the cost of snow removal during FY09
- \$2,611,450 to cover the cost of wind and rain storm clean-up during FY09 (including \$600,000 for anticipated clean-up costs in May and June, subsequent to his request).

The Executive's transmittal memo is on ©1-2, a draft resolution approving this request is on ©3-5, the request summary is on ©6-7, and a breakdown of the costs is on ©8-12. A table describing the list of snow and storm events to which DOT responded in FY09 is on ©13-14. A public hearing was held on June 9, 2009, but there were no speakers.

SUBJECT: Supplemental Appropriation #09-266 to the FY09 Operating Budget
Snow Removal/Wind and Rain Storm Cleanup
Department of Transportation - \$6,645,090
Department of General Services - \$2,611,450

I am recommending a supplemental appropriation to the FY09 Operating Budget of the Departments of Transportation and General Services in the total amount of \$9,256,540 for snow removal and wind and rain storm cleanup. This appropriation funds snow removal and wind and rain storm clean up during FY09.

This increase is needed because expenditures for snow removal and wind and rain storm cleanup exceed the FY09 appropriation by \$9,256,540. As in previous years, due to the unpredictability of snow events, as a matter of practice, only a minimal amount is budgeted for snow removal operations. After review of actual expenses related to staff overtime, contractual services, and materials usage, a supplemental appropriation is requested.

- a. During the winter of 2008-2009, Montgomery County experienced 21 snow/ice events with total accumulation of approximately 14 inches. While some of the events did not result in plowing, both County and contractual personnel were required to report and/or be on standby and equipment was ready and made available based on weather forecasts. The total cost associated with snow removal operations was \$10,636,301, of which \$2,939,370 was budgeted.
- b. Wind and rain storm cleanup expenditures to date are \$1,548,864, of which \$589,260 was budgeted.

- c. In addition to expenditures incurred to date, this supplemental appropriation provides \$600,000 to cover wind and rain storm cleanup costs that we expect to incur in April, May, and June of 2009. Damage from wind and rain storms is unpredictable, with the bulk of the cleanup historically required from April through September.

I recommend that the County Council approve this supplemental appropriation in the amount of \$9,256,540 and specify the source of funds as General Fund Undesignated Reserves. This supplemental will reduce County General Government Fund Reserves by \$9,256,540 and is consistent with our assumptions in the Recommended Budget and the fund balance policy for tax supported reserves.

I appreciate your prompt consideration of this action.

Background

1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
2. The County Executive has requested the following FY09 Operating Budget appropriation increases for the Department of Transportation and the Department of General Services:

3. This increase is needed because expenditures for snow removal and wind and rain storm cleanup exceed the FY09 appropriation by \$6,645,090 in the Department of Transportation and \$2,611,450 in the Department of General Services. As in previous years, due to the unpredictability of snow events, as a matter of practice, only a minimal amount is budgeted for snow removal operations. After review of actual expenses related to staff overtime, contractual services, and materials usage, a supplemental appropriation is requested.
 - a. During the winter of 2008-2009, Montgomery County experienced 21 snow/ice events with total accumulation of approximately 14 inches. While some of the events did not result in plowing, both County and contractual personnel were required to report and/or be on standby and equipment was ready and made available based on weather forecasts. The total cost associated with snow removal operations was \$10,636,301, of which \$2,939,370 was budgeted.
 - b. Wind and rain storm cleanup expenditures to date are \$1,548,864, of which \$589,260 was budgeted.
 - c. In addition, this supplemental appropriation provides \$600,000 for clean-up that the Departments of Transportation and General Services anticipate incurring in April, May, and June of 2009.
4. The County Executive recommends a supplemental appropriation to the FY09 Operating Budget in the amount of \$6,645,090 for the Department of Transportation and \$2,611,450 for the Department of General Services for snow removal and wind and rain storm cleanup and specifies that the source of funds will be General Fund Undesignated Reserves.
5. Notice of public hearing was given, and a public hearing was held.

Glen:

Below is a log of major incidents that Highway addressed.

Additionally, you will see a number of line items noted as "Lead Depot". This is after hours and due of the nature of the threat being forecast (i.e. 50mph winds over a prolonged period or heavy rain with flooding forecast) we determine that a Lead Depot should be assigned including a supervisor and a workforce; the size of which depends on the nature of the forecast. In this case, all ECC calls are forwarded directly to the lead depot.

Finally, Highway responded to 255 calls (to date) after hours with our Person in Charge (PIC) status related to either snow or wind and rain. In the case of the Person In Charge (PIC), all calls from the ECC are forwarded to our PIC phone (rotates among key staff) who in turn, determines the magnitude of the problem and mobilizes appropriate staff to resolve.
