SUBJECT: Public Hearing: Zoning Text Amendment 09-05, Burtonsville Overlay Zone - Allowed Uses

Zoning Text Amendment (ZTA) 09-05, sponsored by Councilmember Navarro, was introduced on June 23, 2009. There are 3 zones beneath the Burtonsville Overlay zone: I-1, I-3, and OM. The permitted land uses in each zone are different. The Planning Board interpreted the current text of the Burtonsville Overlay zone to give a property owner the right to the land uses permitted by the property's underlying zone. A recent court opinion interpreted the Burtonsville Overlay zone to give a property owner in the Overlay zone the right to use any of the uses allowed in the I-1, I-3, and OM zones. ZTA 09-05 would sustain the Planning Board's interpretation of the allowable uses in the zone.

The Planning, Housing, and Economic Development Committee will schedule a worksession at a later date.

AN AMENDMENT to the Montgomery County Zoning Ordinance to:

- amend the land uses allowed in the Overlay zone for the Burtonsville Employment Area of the Fairland Master Plan; and
- generally amend the Overlay zone for the Burtonsville Employment Area of the Fairland Master Plan.

By amending the following section of the Montgomery County Zoning Ordinance, Chapter 59 of the Montgomery County Code:

DIVISION 59-C-18	“Overlay Zones”
Sec. 59-C-18.14.	“Overlay zone for the Burtonsville Employment Area of the Fairland Master Plan”
59-C-18.142	“Regulations”

ORDINANCE

The County Council for Montgomery County, Maryland, sitting as the District Council for that portion of the Maryland-Washington Regional District in Montgomery County, Maryland, approves the following ordinance:

9 (a) Land uses. [The following uses are allowed in the Burtonsville employment
10 overlay zone:]

11 (1) All permitted or special exception uses [in the I-1, I-3, and O-M zones
12 as shown in Sections 59-C-4.2 and 59-C-5.2 except] in a lot or
13 parcel's underlying zone are allowed; however, the following uses are
14 prohibited:

15 Automobile parts, sales and services, including but not limited
16 to tire sales and transmission service

17 Automobile filling stations

18 Automobile repair and services

19 Automobile sales, indoors and outdoors

20 Automobile, truck and trailer rentals, outdoor

21 Bakery

22 Blacksmith shops[,] and machinery shops

23 Bottling plant

24 Building materials and supplies, wholesale and retail

25 Confectionery production

26 Contractor's storage yards

27 Dry cleaning plants

- 28 Electroplating and manufacturing of small parts such as coils,
29 condensers, transformers, and crystal holders
30 Food production, packaging, packing and canning [of]
31 Fuel storage yards
32 Ice manufacturing and storage
33 Laundry plants
34 Lumberyards
35 Manufacturing of light sheet metal products

- 73 Florist.
- 74 Food and beverage store.
- 75 Newsstand.
