- Membership – 12 members and the supervisor of school libraries serves as an Ex-Officio School Board Representative.
- Financial Disclosure - Not required.
- Terms – Up to two three-year terms - no compensation.
- Meetings – Second Wednesday of each month at 7:00 p.m.



**Leggett Seeks Applicants for Library Board**

County Executive Isiah Leggett is seeking applicants to fill six vacancies on the Library Board. Four incumbents are eligible to apply for reappointment.

The 12-member Advisory Board gives community input to the County Executive on matters affecting the public library system. Members serve three-year terms without compensation. Meetings are held the second Wednesday of each month at 7:00 p.m. in the Department of Public Libraries, Administrative Offices, on the third floor of the Rockville Library located at 21 Maryland Avenue, Suite 310, Rockville. Each Board member serves as liaison to assigned Library Advisory Committees, which may involve additional meetings each month.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply, and should write by June 26 to County Executive Isiah Leggett at the Executive Office Building, 101 Monroe Street, Rockville, MD 20850 or send an e-mail to [countyexecutive.boards@montgomerycountymd.gov](mailto:countyexecutive.boards@montgomerycountymd.gov). A brief resume, including home and work telephone numbers, should be included.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Members of this Board are eligible for reimbursement for travel and dependent care for meetings attended. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
