ADVISORY COMMITTEE ON CONSUMER PROTECTION

- Created -- Montgomery County Code Section 11-3.
- Purpose -- The Committee shall advise the Office of Consumer Protection in carrying out its duties and functions under this Chapter, and shall hold public hearings as deemed necessary, including hearings on inclusion or exclusion of persons or organizations from application of the provisions of this Chapter.
- Membership -- Nine members - at least two from the Better Business Bureau or another County-wide association of merchants, at least two from the Community Action Board (one representing the economically disadvantaged), and five from the community at large.
- Financial Disclosure - Not required.
- Terms -- Three year terms - no compensation.
- Meetings -- 1st Tuesday evening of each month, 8:00 AM, COB, 2<sup>nd</sup> Floor

**Leggett Seeks Applicants for Advisory Committee On Consumer Protection**

County Executive Isiah Leggett is seeking applicants to fill three public-at-large vacancies on the Advisory Committee on Consumer Protection. The three incumbents are eligible to apply for reappointment.

The nine-member committee advises the County's Office of Consumer Protection. Members serve three-year terms without compensation. Meetings are generally held the first Tuesday morning of each month in Rockville at 8:00 a.m.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply. An application, consisting of a **brief cover letter and resume**, should be sent by mail to County Executive Isiah Leggett, 101 Monroe Street, 2nd Floor, Rockville, MD 20850, or by email to [countyexecutive.boards@montgomerycountymd.gov](mailto:countyexecutive.boards@montgomerycountymd.gov). Home and employment addresses, as well as contact phone numbers and email addresses should be included. If appropriate, applicants should indicate the position for which they are applying. The deadline for application is **August 28**.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Members of this Committee are eligible for reimbursement for travel and dependent care for meetings attended. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
