**INTERAGENCY COORDINATING BOARD FOR
COMMUNITY USE OF PUBLIC FACILITIES**

- Created – Montgomery County Code, Section 44-3 (as amended 1997).
- Purpose – To promote community use of public school facilities; encourage interagency cooperation regarding the community use of public school facilities; adopt regulations necessary for community use of those facilities; recommend fee schedules to the County Executive and County Council; review major contracts and grants to be negotiated between the County and MCPS; to review budget prepared by the Executive Director and make budget recommendations thereon to the Chief Administrative Officer, County Executive and County Council.
- Membership – Nine voting members consisting of: (1) Chief Administrative Officer, (2) Superintendent of Schools, (3) President of Montgomery College, (4) member of the Montgomery County Planning Board, designated by Montgomery County members of M-NCPPC, (5) a representative of the County Council; (6) **one citizen appointed by the Superintendent of Schools and confirmed by the Board of Education**, and (7) **three citizens appointed by the County Executive and confirmed by the County Council**. Three non-voting ex-officio members: one member of the Board of Education selected and appointed by the BOE; one representative of secondary school principals (confirmed by the County Council), and one representative of elementary school principals (confirmed by the County Council) each appointed by the Montgomery County Association of Administrative and Supervisory Personnel.
- Financial Disclosure-Not required.
- Terms – Citizen members serve four-year terms - no compensation.
- Meetings – Meetings are held on Wednesdays or Thursdays from 8 to 10 a.m. approximately 4 times a year (Jan., March, June, Dec.).



Leggett Seeks Applicants for Interagency Coordinating Board

County Executive Isiah Leggett is seeking applicants to fill one public vacancy on the Interagency Coordinating Board for Community Use of Public Facilities.

The Interagency Coordinating Board has nine voting members including: the Chief Administrative Officer, the Superintendent of Schools, the President of Montgomery College, one member of the Planning Board, a representative of the County Council, one citizen appointed by the Superintendent of Schools and confirmed by the Board of Education, and three citizens appointed by the County Executive and confirmed by the County Council. There are also three ex-officio, non-voting members including: one member of the Board of Education; one representative of elementary school principals, and one representative of secondary school principals, each appointed by the Montgomery County Association of Administrative and Supervisory Personnel. The Board makes policy decisions on the community use of public facilities, and is committed to making public facilities accessible and affordable to all individuals and organizations.

Members of the Board serve four year terms without compensation, but are eligible for reimbursement for travel and dependent care for meetings attended. The Board meets quarterly to discuss and take actions on issues concerning the use of public facilities. Meetings are usually held on Wednesdays from 8:00 a.m. to 10:00 a.m. in Rockville.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply. An application, consisting of a **brief cover letter and resume**, should be sent by mail to County Executive Isiah Leggett, 101 Monroe Street, 2nd Floor, Rockville, MD 20850, or by email to countyexecutive.boards@montgomerycountymd.gov. Home and employment addresses, as well as contact phone numbers and email addresses should be included. If appropriate, applicants should indicate the position for which they are applying. The deadline for application is **March 19**.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
