- Purpose -- To provide advice to the County Executive and the County Council through the Director of the Bethesda-Chevy Chase Regional Services Center on: area priorities, needs of the Western Montgomery County region for programs and/or services, impact of current services (effectiveness), identification and understanding of the Western Montgomery County communities, and proposed changes in government services for the Western Montgomery County area.



County Executive Isiah Leggett is seeking applicants to fill nine vacancies on the Western Montgomery County Citizens Advisory Board, for three business representatives, one of whom should be from a non-profit business in the regional services area, and six residential representatives, two of whom should be residents of the City of Rockville.

The 19-member Board represents the residential and business communities of Bethesda, Cabin John, Chevy Chase, Friendship Heights, Garrett Park, Glen Echo, North Bethesda, Potomac and Rockville. The Board advises the Director of the Bethesda-Chevy Chase Services Center, the County Executive and the County Council on community needs and priorities such as transportation, human services, environmental, public safety, and other issues of local importance.

Members serve three-year terms without compensation, but are eligible for reimbursement for travel and dependent care for meetings attended. Board meetings are held the third Monday of the month, and begin at 7:00 p.m. Committee meetings may be held in the morning or evening depending on the issues to be discussed. Members are expected to contribute approximately six hours each month, and to attend both board and committee meetings.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply. An application, consisting of a **brief cover letter and resume**, should be sent by mail to County Executive Isiah Leggett, 101 Monroe Street, 2nd Floor, Rockville, MD 20850, or by email to countyexecutive.boards@montgomerycountymd.gov. Home and employment addresses, as well as contact phone numbers and email addresses should be included. If appropriate, applicants should indicate the position for which they are applying. The deadline for application is **March 2**.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
