FIREARM SAFETY COMMITTEE

- Created -- Montgomery County Code Section 57-2, amended 1991
- Purpose -- To issue approval certificates for target, trap and skeet range, and shooting areas which specify the type of gun or ammunition that may be used on such range or area. The committee also makes recommendations to the County Executive and the County Council concerning the extension of the maximum expansion area boundaries as well as the boundaries of the urban area.
- Membership -- Seven voting members - no compensation. The Police Range Officer is a non-voting member.
- Officers -- Chairman designated by the County Executive from among the voting members.
- Financial Disclosure - Not required.
- Terms -- Three year terms



Leggett Seeks Applicants for Firearm Safety Committee

County Executive Isiah Leggett is seeking applicants to fill three vacancies on the Firearm Safety Committee. Members should be knowledgeable by training and experience in the safe and sportsmanlike use of weapons. Two incumbents are eligible to apply for reappointment.

The seven-member committee issues indoor and outdoor target, trap, skeet and range shooting approval certificates which specify the time and manner of shooting and the type of gun and ammunition which can be used on the range.

Members serve three-year terms without compensation. The Committee currently meets on an as-needed basis at the various shooting ranges in the County and at the Public Service Training Academ in Rockville.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply. An application, consisting of a **brief cover letter and resume**, should be sent by mail to County Executive Isiah Leggett, 101 Monroe Street, 2nd Floor, Rockville, MD 20850, or by email to countyexecutive.boards@montgomerycountymd.gov. Home and employment addresses, as well as contact phone numbers and email addresses should be included. If appropriate, applicants should indicate the position for which they are applying. The deadline for application is **October 23**.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Members of this Committee are eligible for reimbursement for travel and dependent care for meetings attended. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
