Leggett Seeks Applicants for Mid-County Citizens Advisory Board

County Executive Isiah Leggett is seeking applicants to fill one vacancy on the Mid-County Citizens Advisory Board.

The Board is comprised of 15 residents and business from the following areas: Upper Rock Creek, Wheaton, Kensington, Kemp Mill, Aspen Hill, Glenmont, Norbeck, Forest Glen, Olney, Brookeville, and Sandy Spring. The Board serves as a liaison between the community, the County Executive, County Council, and County government departments by identifying community concerns and recommending possible solutions. It also advises the Director of the Mid-County Services Center on transportation, economic development, housing, education, human services, environment, recreation, public safety and other issues of importance to the area.

Members serve three-year terms without compensation, but are eligible for reimbursement for travel and dependent care for meetings attended. Meetings are usually held the third Tuesday evening of each month at the Mid-County Services Center, 2424 Reedie Drive, Wheaton.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply. An application, consisting of a **brief cover letter and resume**, should be sent by mail to County Executive Isiah Leggett, 101 Monroe Street, 2nd Floor, Rockville, MD 20850, or by email to countyexecutive.boards@montgomerycountymd.gov. Home and employment addresses, as well as contact phone numbers and email addresses should be included. If appropriate, applicants should indicate the position for which they are applying. The deadline for application is **January 8**.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
