**GLEN ECHO PARK PARTNERSHIP
FOR ARTS AND CULTURE, INC.
BOARD OF DIRECTORS**

- Created:** Articles of Incorporation and Bylaws of the Glen Echo Park Operating Entity, Inc. 2002
- Purpose:** The Glen Echo Park Board of Directors will provide policy guidance to direct the affairs of the organization and its management; will lead efforts to raise funds to support the mission of the organization; will provide oversight for the (a) program, (b) site and facilities, (c) finances and (d) public relations activities of the organization.
- Membership:** No fewer than nine (9) and no more than twenty-five (25) members. Members shall be reflective of the interests of the community, including park users, cooperators, residents of the surrounding neighborhoods and the general public. At least one member shall be a person who is a resident of the Town of Glen Echo, designated by the Town of Glen Echo; at least one member of the Board shall be a person who is a resident of Bannockburn, designated by the Bannockburn Civic Association; three (3) members to be appointed by the County Executive if the board is between 9 and 12; four (4) members to be appointed if the board is larger. Note: The County Executive and President of the County Council or their designees are non-voting ex-officio members.

- Terms:** Three year terms without compensation

County Executive Isiah Leggett is seeking applicants to fill two vacancies on the Board of Directors for Glen Echo Park Partnership for Arts and Culture, Inc.

The management plan for Glen Echo Park calls for the non-profit organization to manage and provide stewardship for Glen Echo Park and to assure its long-term success and sustainability as an important community institution. The Park is recognized for its vibrant mix of educational, cultural, environmental and recreational programs. It is a center for aspiring as well as accomplished artists. The Park serves approximately 450,000 visitors annually. The Partnership's 21-member Board of Directors provides policy guidance to direct the affairs of the organization and its management, provides oversight for the programs, the site and the facilities, and will lead efforts to raise funds to support the mission of the organization.

Members serve three-year terms without compensation, but are eligible for reimbursement for travel and dependent care for meetings attended. Members of the Board are expected to attend regular monthly meetings held the second Wednesday evening of each month at Glen Echo Park. Members must also participate on at least one of the Board's committees.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply. An application, consisting of a **brief cover letter and resume**, should be sent by mail to County Executive Isiah Leggett, 101 Monroe Street, 2nd Floor, Rockville, MD 20850, or by email to countyexecutive.boards@montgomerycountymd.gov. Home and employment addresses, as well as contact phone numbers and email addresses should be included. If appropriate, applicants should indicate the position for which they are applying. The deadline for application is **April 26**.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
