COMMISSION ON CHILDREN AND YOUTH

- Created -- Montgomery County Code Section 27-48
- Purpose -- To advise the County Executive and County Council, the Department of Health and Human Services and the Board of Education on the development of coordinated community and government policies, programs and services which support children, youth and families.
- Membership -- 27 members including one representative from the public school system; one representative from the private schools in the County; one representative from the Department of Recreation; and two representatives from the Department of Health and Human Services. The remaining 22 members should be divided as equally as possible among individuals with recent experience in agencies providing services to children and youth; youth and young adults; and parents. *The Chair and Vice Chair shall be appointed by the County Executive and confirmed by the County Council! (The Commission may make recommendations to the CE)*
- Financial Disclosure -- Not required.
- Terms -- 3 year terms for parents and agency representatives; one year terms for youth (June 1 – May 31). There is no compensation.
- Meetings -- 2nd Wednesday of each month.


