


County Executive Isiah Leggett is seeking applicants to fill seven vacancies on the Noise Control Advisory Board.

The eleven-member board must advise the County Executive, County Council, and the Director of the Department of Environmental Protection on noise control issues. The Board reviews and makes recommendations on the effectiveness of the County's noise control rules and regulations.

Members serve three-year terms without compensation and meetings are held the second Monday of every other month in Rockville. Members are required to review related materials prior to meetings.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply. An application, consisting of a **brief cover letter and resume**, should be sent by mail to County Executive Isiah Leggett, 101 Monroe Street, 2nd Floor, Rockville, MD 20850, or by email to countyexecutive.boards@montgomerycountymd.gov. Home and employment addresses, as well as contact phone numbers and email addresses should be included. If appropriate, applicants should indicate the position for which they are applying. The deadline for application is **November 13**.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Members of this Board are eligible for reimbursement for travel and dependent care for meetings attended. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
