SUBJECT: Interviews: Redistricting Commission – Applicants and Nominees

The Council must establish a Commission on Redistricting no later than February 1, 2011. The Commission shall be composed of four members each from the Democratic and Republican parties from a list of eight individuals submitted by the central committee of each party. Each list shall include at least one individual who resides in each Council district. The Council shall appoint one additional member of the Commission. The number of appointed members who reside in the same Council district shall not exceed two. No person who holds any elected office shall be eligible for appointment to the Commission. The Commission at its first meeting shall select one of its members to serve as its chair.

As this is a unique Commission, the Council will interview all nominees and applicants. Please note that the Republican Central Committee has updated its list of nominees so that it contains nominations from each Council district as required by the Charter. Mr. Uncapher, Chairman of the Republican Central Committee, transmitted the revised list on November 30. The Council will make the appointments in January; November 15, 2011 is the deadline for the Commission to present the Redistricting Plan to the Council.
