## AGRICULTURAL ADVISORY COMMITTEE

- Created -- Council Resolution No. 8-705 (1976)
- Purpose -- To advise the County Executive and the County Council on all matters affecting agriculture in Montgomery County.
- Membership -- 15 members. Twelve members shall be bona fide farmers selected so as to be representative of the total farm community and three members shall have no direct financial interest in farming. At least one farm economist and one conservationist shall be included in the committee membership.
- Financial Disclosure -- Not required.
- Terms -- Farmer representatives serve three year terms. Non-farmer representatives serve one year terms. No compensation.



### Leggett Seeks Applicants for Agricultural Advisory Committee

County Executive Isiah Leggett is seeking applicants to fill seven vacancies on the Agricultural Advisory Committee. Four positions are for bona fide farmers selected to represent the total farm community, and three positions are to be filled by non-farmers.

The 15-member committee advises the County Executive and County Council on all matters affecting agriculture in the County. Membership includes farmers, non-farmers, and at least one farm economist and one conservationist.

Farmer representatives serve three-year terms and non-farmer members serve one-year terms. Members serve without compensation, but are eligible for reimbursement for travel and dependent care for meetings attended. Meetings are held on the third Tuesday evening of each month in Germantown.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply. An application, consisting of a **brief cover letter and resume**, should be sent by mail to County Executive Isiah Leggett, 101 Monroe Street, 2<sup>nd</sup> Floor, Rockville, MD 20850, or by email to [countyexecutive.boards@montgomerycountymd.gov](mailto:countyexecutive.boards@montgomerycountymd.gov). Home and employment addresses, as well as contact phone numbers and email addresses should be included. If appropriate, applicants should indicate the position for which they are applying. The deadline for application is **November 12, 2010**.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
