Leggett Seeks Applicants for Committee for Ethnic Affairs

County Executive Isiah Leggett is seeking applications to fill three vacancies on the Committee for Ethnic Affairs.

The 26-member Committee serves as an advisory group to the County Executive, County Council, and the Office of Community Partnerships about ethnic affairs. Specific objectives of the Committee are to create a forum for all ethnic groups in the County, to help integrate diverse communities in the County, to identify existing and potential problems and possible solutions, and to promote maximum involvement of all residents in the County's government, business and community affairs.

Committee members serve three-year terms without compensation, but are eligible for reimbursement for travel and dependent care for meetings attended. Meetings are held on the first Thursday of each month at 7:00 p.m. in Rockville.

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply. An application, consisting of a **brief cover letter and resume** (detailing description of interests, experience, community group affiliations and community activities) should be sent by mail to County Executive Isiah Leggett, 101 Monroe Street, 2nd Floor, Rockville, MD 20850, or by email to countyexecutive.boards@montgomerycountymd.gov. Home and employment addresses, as well as contact phone numbers and email addresses should be included. If appropriate, applicants should indicate the position for which they are applying. The deadline for application is **November 19, 2010**.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
