AN ACT to:

- (1) require the Department of Permitting Services to implement ~~[[an expedited]]~~ a fast track review process for permits to install electric vehicle charging stations that meet standardized requirements adopted by the Department for single family detached homes;
- (2) require the Department to ~~[[charge reduced]]~~ set fees for permits to install electric vehicle charging stations that meet standardized requirements adopted by the Department for single family detached homes; and
- (3) generally amend County law regarding building permits.

4 The Department must adopt ~~[[an expedited]] a fast track review process for~~
5 each permit to install an electric vehicle charging station at a single family
6 detached home that meets standardized requirements adopted by the Department.


7 The Department must set the application fee by Executive Regulation adopted
8 under Method 2 for each permit to install an electric vehicle charging station at a
9 single family detached home that meets standardized requirements adopted by the
10 Department ~~[[must not exceed half the amount the Department charges for a~~


