**Sec. 1. Section 2-60 is amended as follows:**

**2-60. Criminal Justice Coordinating Commission.**

(a) *Established.* There is a Criminal Justice Coordinating Commission.

(b) *Composition; officers; terms of members; meetings; staff.*

(1) The Commission has 32 members.

(3) The following individuals are ex-officio members of the Commission:

(A) Chair of the County Council's Public Safety Committee, or  
another member of the Public Safety Committee;

**Sec. 2. Expedited Effective Date.**
