SUBJECT: Designation of full-time member who serves as Chair or Vice Chair of the Maryland-National Capital Park and Planning Commission; Appointment of Chair of Montgomery County Planning Board; Authorization of Supplemental Salary and Leave

Background

1. Casey Anderson's first term as a member of the Maryland-National Capital Park and Planning Commission expires on June 14, 2015. Mr. Anderson was originally appointed as a member in June 14, 2011.
2. Section 15-107 of the Land Use Article of the Maryland Code authorizes the Council to designate a member to serve on a full-time basis as the Chair or Vice Chair of the Commission. Mr. Anderson was designated by the Council on July 15, 2014, to serve as Chair or Vice Chair of the Commission and as Chair of the Montgomery County Planning Board.
3. Section 15-108 of the Land Use Article of the Maryland Code states that "with the approval of the County Executive of Montgomery County, the County Council may authorize an appropriate supplementary salary for the commissioner designated by Montgomery County to serve on a full-time basis."
4. Section 15-102 of the Land Use Article of the Maryland Code provides that the term of office of each member of the Commission is four years and in Montgomery County a person may not be appointed for three consecutive full terms, with the following exception. A commissioner appointed from Montgomery County may be appointed for a maximum of three consecutive full terms as a member of the Commission if the commissioner is designated as chair of the Montgomery County Planning Board during the commissioner's second term in office. This provision, Chapter 446 effective July 1, 2015, was approved with retroactive application for any Commissioner appointed on or after June 15, 2014. Therefore, at the conclusion of his second term in 2019, Mr. Anderson would be eligible to apply for reappointment as Chair.
5. Current Commission members are: Chair Casey Anderson (Democrat), Norman Dreyfuss (Republican), Amy Presley (Republican), Natali Fani-Gonzalez (Democrat) and Marye Wells-Harley (Democrat).
6. The designation of a full-time Commissioner and Chair of the Planning Board is before the Council for approval.

Action

The County Council for Montgomery County, Maryland approves the following resolution:

1. Supplementary Salary Authorization

The Chair of the Montgomery County Planning Board must receive a salary of \$200,000 including the mandatory salary provided under State law. The salary must be adjusted on the annual anniversary of the first day of the term of office by a percentage which is 75 percent of the percentage increase in the Washington-Baltimore Metropolitan Area Consumer Price Index of all urban consumers for May from the preceding May.

2. Leave

The Montgomery County Planning Board Chair must accrue leave on the basis of four weeks per year for vacation and personal leave.

3. Appointment

Mr. Casey Anderson is reappointed for a second term to the Maryland-National Capital Park and Planning Commission until June 14, 2019, or until a successor has been appointed and qualified.

4. Designation as Full-time member and as Chair or Vice Chair


Mr. Anderson is designated as Chair or Vice Chair of the Maryland-National Capital Park and Planning Commission. In that capacity Mr. Anderson is designated to serve as Chair of the Montgomery County Planning Board effective June 15, 2015, until June 14, 2019.


5. Effective Date

The effective date of the appointment and supplementary salary and leave authorized in this resolution is the later of June 14, 2015, or the date that the resolution is approved by the County Executive.
