Background

1. The County Council believes that a strong partnership with nonprofit organizations is critical in meeting the county's health and human services and community needs. These partnerships come through competitive contracts and grants, and from proposals made directly from the nonprofit community to the County Council. The Council has established an FY2017 grants process that will require nonprofit organizations seeking funds from the County Council to submit a Council grant application form by January 13, 2016.
2. To assist the Council in its review of grant proposals from the nonprofit community, the Council will appoint a community Grants Advisory Group to review grant applications.
3. The County Council will designate the Chair of the Group. The Group is scheduled to complete its work and report to the Council by April 29, 2016.


