SUBJECT: Amendment to Fiscal Year 2017 Operating Budget
Resolution 18-506, Section G, Fiscal Year 2017 Designation of Entities for
Non-Competitive Contract Award Status – Montgomery County Bar Foundation,
Inc.; Catholic Charities of the Archdiocese of Washington, Inc; Montgomery
County Collaboration Council for Children, Youth, and Families

Background

1. Section 11B-14 (a) (4) of the Montgomery County Code states that “a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council.” The result of this action is to amend the Fiscal Year (FY) 2017 Designation of Entities for Non-Competitive Contract Award status resolution to include the agency listed below.
2. The Chief Administrative Officer has determined that funding for contracts with these entities serve a public purpose and that such expenses would be in the public interest.
3. The Department of Health and Human Services and the Department of Recreation will fund the contracts with the Providers listed from existing appropriations for FY 2017.
4. The Department of Health and Human Services will develop a new contract with the Maryland Bar Foundation, Inc. and Catholic Charities of the Archdiocese of Washington, Inc. (Spanish Catholic Center), for provision of services as stated in the amended FY 2017 Designation of Entities for Non-Competitive Contract Award.
5. The Department of Recreation will develop a new contract and amend an existing contract with the Montgomery County Collaboration Council for Children, Youth, and Families, Inc.

Action

The County Council for Montgomery County, Maryland, approves the following action:

The Council approves an amendment to the Designation of Entities for Non-Competitive Contract Award and thereby amends Resolution 18-506, Section G, FY 2017 Designation of Entities for Non-Competitive Contract Award. The Chief Administrative Officer has recommended this action and stated that amending the contracts for these vendors serves a public purpose and is in the public interest.

The FY 2017 Designation of Entities for Non-Competitive Contract Award Status resolution is amended to:


Department of Health and Human Services:

- Correct the stated purpose for the Montgomery County Maryland Bar Foundation, Inc. in the amount of \$10,000 from “Provides for legal services for Pro Bono case referrals and brief advice at legal advice clinics to low-income residents” to “Provide a part-time position to allow access to pro bono/low-fee legal advice and services to self-represented litigants within the Family Court.”
- Correct the stated entity for one of the Catholic Charities contracts to include “(Spanish Catholic Center)” to provide employment referral services and job readiness workshops for Latino and new-immigrant residents in the amount of \$50,000. The new entity name will read: Catholic Charities of the Archdiocese of Washington, Inc. (Spanish Catholic Center).

Department of Recreation:

- Correct the amount of the contract with the Montgomery County Collaboration Council for Children, Youth, and Families, Inc. to provide Excel Beyond the Bell programs from \$175,000 to \$446,000.
- Add a new contract with the Montgomery County Collaboration Council for Children, Youth, and Families, Inc. to “Provide for reporting for Child First programs” in the amount of \$15,000.
