**SUBJECT:** Amendment to Fiscal Year 2017 Operating Budget  
Resolution 18-506, Section G, Fiscal Year 2017 Designation of Entities for  
Non-Competitive Contract Award Status

**Background**

1. Section 11B-14 (a) (4) of the Montgomery County Code states that “a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council.” The result of this action is to amend the Fiscal Year (FY) 2017 Designation of Entities for Non-Competitive Contract Award status resolution to include the agencies listed below.
2. The Chief Administrative Officer has determined that funding for the contracts with these entities serves a public purpose and that such an expense would be in the public interest.
3. The Department of Health and Human Services (DHHS) will fund contracts with Providers listed below from existing appropriations for FY17.
4. The DHHS will add contracts with the Primary Care Coalition of Montgomery County, Maryland, Inc., The National Center for Children and Families, Inc., Columbia Lighthouse for the Blind; and The Montgomery County Coalition for the Homeless, Inc., for provision of services as stated in the amended FY17 Designation of Entities for Non-Competitive Contract Award.

**Action**

The County Council for Montgomery County, Maryland, approves the following action:

The Council approves an amendment to the Designation of Entities for Non-Competitive Contract Award and thereby amends Resolution 18-506, Section G, FY17 Designation of Entities for Non-Competitive Contract Award. The Chief Administrative Officer has recommended this action and stated that amending or establishing contracts with these vendors serves a public purpose and is in the public interest.

The FY17 Designation of Entities for Non-Competitive Contract Award Status resolution is amended to:

1. Increase funding for the Primary Care Coalition of Montgomery County, Maryland, Inc.'s contract for the Care for Kids Program in the amount of \$132,000 due to increased enrollment, to provide primary care and specialty care services to low income children who do not qualify for state or federal health insurance.
2. Establish a contract with The National Center for Children and Families, Inc. in the amount of \$65,000 to read "Provides for respite care and wraparound services for undocumented male youth, ages 16 through 20, for 90 days in the Greentree Adolescent Program."
3. Establish a contract with Columbia Lighthouse for the Blind in the amount of \$25,000 to read "Provides for the Montgomery County Deaf-Blind program, assisting the deaf-blind populations in remaining independent by providing Support Service Provider services."
4. Establish a contract with The Montgomery County Coalition for the Homeless, Inc., in the amount of \$86,500 to read "Provides for the KEYS FIRST program for formerly homeless single adults and families."
