**SUBJECT:** Amendment to Fiscal Year 2017 Operating Budget, Resolution 18-506, Section G, Fiscal Year 2017 Designation of Entities for Non-Competitive Contract Award Status: The National Center for Children and Families, Inc.; The Shepherd's Table; Bethesda Cares, Inc.; Interfaith Works, Inc.; IMPACT Silver Spring; Community Clinics, Inc.

**Background**

1. Section 11B-14 (a) (4) of the Montgomery County Code states that "a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council." The result of this action is to amend the Fiscal Year (FY) 2017 Designation of Entities for Non-Competitive Contract Award status resolution to include the agency listed below.
2. The Chief Administrative Officer has determined that funding for contracts with these entities serve a public purpose and that such expenses would be in the public interest
3. The Department of Health and Human Services (DHHS) will fund the contracts with the Providers listed below with existing appropriations for FY 2017.
4. The DHHS will amend the contracts with The National Center for Children and Families, Inc., The Shepherd's Table, Inc., Bethesda Cares, Inc., Interfaith Works, Inc., IMPACT Silver Spring, Inc., and Community Clinics, Inc. for provision of services as stated in the amended FY 2017 Designation of Entities for Non-Competitive Contract Award

**Action**


The County Council for Montgomery County, Maryland approves the following resolution:

The Council approves an amendment to the Designation of Entities for Non-Competitive Contract Award and thereby amends Resolution 18-506, Section G, FY 2017 Designation of Entities for Non-Competitive Contract Award. The Chief Administrative Officer has recommended this action and stated that amending the contracts for these vendors serves a public purpose and is in the public interest.

The FY17 Designation of Entities for Non-Competitive Contract Award Status resolution is amended to:

1. Amend the purpose of the \$84,088 contract with The National Center for Children and Families Inc. from, "Provides a cash match to Housing and Urban Development (HUD) Continuum of Care grants for Case management," to, "Provides for case management to people served through the Continuum of Care." The contract amount will be increased by \$31,648 for a new contract total of \$115,736.
2. Increase the new contract with The Shepherd's Table, Inc. that reads, "Provides support (Homeless Outreach) services to homeless individuals at Progress Place," in the amount of \$74,562 for a new contract total of \$209,292.
3. Establish a new contract with Bethesda Cares, Inc. in the amount of \$80,000 to read, "Provides for creation of a Special Needs Housing (SNH) outreach team in Silver Spring."
4. Establish a new contract with Interfaith Works, Inc. in the amount of \$25,000 to read, "Provides for creation of a Special Need Housing (SNH) outreach team in the Silver Spring area."
5. Amend the purpose of the \$252,500 contract with IMPACT Silver Spring, Inc. from, "Provides leadership training courses for Silver Spring residents," to, "Provides training to County residents and community forums/events to impact skills, relationship building and information sharing."
6. Establish a new contract with Community Clinic, Inc. in the amount of \$100,000 to read, "Provides one-time renovation support for the relocation of the Women, Infants, and Children (WIC) Program."
