Resolution 18-823, Section G, Fiscal Year 2018 Designation of Entities for

Non-Competitive Contract Award Status

Background

- 1. Section 11B-14 (a) (4) of the Montgomery County Code states that "a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council." The result of this action is to amend the Fiscal Year (FY) 2018 Designation of Entities for Non-Competitive Contract Award status resolution to include the agencies listed below.
- 2. The Chief Administrative Officer has determined that funding for the contracts with these entities serves a public purpose and that such an expense would be in the public interest.
- 3. The Office of the County Executive will fund the contract with WorkSource Montgomery, Inc. from an existing appropriation for FY18, the Department of General Services will fund the contract with Sandy Spring Museum, Inc. from unspent appropriation from an FY16 Capital Improvement Grant in the Cost Sharing: MCG Project 720601, and the Department of Health and Human Services will fund the contract with the Jewish Council for the Aging of Greater Washington, Inc. from existing FY18 appropriations.
- 4. The Office of the County Executive, Department of General Services, and Department of Health and Human Services will amend contracts with WorkSource Montgomery, Inc, Sandy Spring Museum, Inc., and the Jewish Council for the Aging of Greater Washington, Inc. for provision of services as stated in the amended FY18 Designation of Entities for Non-Competitive Contract Award.

Action

The County Council for Montgomery County, Maryland, approves the following action:

The Council approves an amendment to the Designation of Entities for Non-Competitive Contract Award and thereby amends Resolution 18-823, Section G, FY18 Designation of Entities for Non-Competitive Contract Award. The Chief Administrative Officer has recommended this action and stated that amending the contract for this vendor serves a public purpose and is in the public interest.

The FY18 Designation of Entities for Non-Competitive Contract Award Status resolution is amended to:

- 1. Increase an existing contract with WorkSource Montgomery, Inc. by \$80,000 to \$1,737,344 to include the One-stop Satellite Center at the Montgomery County Correctional Facility
- 2. Modify the purpose of an existing contract with the Sandy Spring Museum, Inc. from: "Provides for the renovation of its pottery shed, weatherizing the building, and the renovation of its education room to make it more usable" to "Provides for the renovation of its pottery shed, weatherizing the building, the renovation of its education room to make it more usable, and the removal and replacement/installation of the heat and air conditioning system, including a humidifier in the Sandy Spring Archives Room."
- 3. Modify the purpose of the existing contract with the Jewish Council for the Aging of Greater Washington, Inc. from "Provides for the Intergenerational Bridges program" to "Provides for intergenerational mentoring and tutoring for young people."
