# III. Reports of Special Committees.

Adriana Hochberg, Climate Change Coordinator for County Executive Mark Elrich made a presentation on Climate Action Planning in Montgomery County.

- Ms. Hochberg described several MoCo environmental programs related to the environment, energy and climate change
- The county's goals are to reduce greenhouse gases by 80% by 2027 and 100% by 2035 (relative to the 2005 level)
- Trends since 2010 show increasing rainfall and severe storms leading to more serious flooding and increased damage to property.
- Five workgroups, with over 150 members, are developing an action plan. The members represent dozens of organizations and individuals.
   A draft plan will be available for public review in late 2020 and it will be finalized in early 2021.
- In developing options, the workgroups and later reviewers are considering environmental, economic, and equity impacts.
- The County is also taking actions while the long-range plan is being developed. Examples are:
  - Considering a 6-megawatt community solar installation at the Oaks landfill.
  - Changing building codes and energy performance standards
  - o Designing Bus Rapid Transit routes and acquiring electric buses

# IV. Unfinished Business and General Orders.

#### Status of Vacancies:

The WQAG currently has 4 vacancies, two members who are at the end
of their second term have requested waivers so that they can continue
to serve. Currently there are no agricultural representatives, and only
one representative each for academic, environmental and business. The
new online application tool is up and running but it is not clear when we
will be able to advertise.

### Meeting Calendar:

 Kate Bennett has placed the WQAG meeting dates for 2020 on the official calendars.

### **Group Discussions:**

- Frank Dawson noted that road salting increases salt levels in streams, causes pipe corrosion, and can even affect drinking water and private wells. A related issue is balancing pubic expectations for ice-free roads and reduced salt usage. DEP will do press event on January 16 focused on what residents can do to manage their salt usage. County Executive Erlich will ask county agencies, schools, etc to sign pledges to use less salt. Private applicators (for parking lots, HOAs, driveways, etc.) often overuse salt because clients expect to see salt on the ground to know it is being applied. The County may need a salt management plan for sustainability.
- The County budget is scheduled for release in mid-March.
