WHEREAS, Grantor desires to develop the Property in a manner that requires a stormwater management system, as defined in County law; and

NOW, THEREFORE, GRANTOR covenants and agrees as follows:

1. Grantor grants to the County a stormwater management right of entry over, through, and under the Property as shown on the approved Record Drawing Plan authorized by Sediment Control Permit [add sediment control permit number here], which is maintained by the Montgomery County Department of Environmental Protection and is incorporated herein by reference. Grantor further agrees to be bound by all covenants, terms, conditions and obligations of the Grantor as set forth in the Master Declaration of Terms and Conditions of Stormwater Management Right of Entry and Maintenance Agreement dated August 9, 2017, also incorporated herein by reference, and recorded at Liber 54725 Folio 379 among the Land Records of Montgomery County, Maryland.

2. This Right of Entry runs with the land and binds Grantor and any subsequent representatives, successors or assigns of Grantor. This Right of Entry may not be terminated without the County's written consent. [Note that each owner, as listed on the property deed, must sign the document in the presence of a Notary. It may be necessary to add additional signatory and Notary pages to this document.]
