Re: Annual Quarry License Certification, Travilah Quarry, 13900 Piney Meetinghouse Rd., Rockville

Dear Mr. Bevard:

I am in receipt of Aggregate Industries' submittal received December 26, 2023 and subsequent information received February 26, and March 29, 2024, containing records and documents as part of your annual license review and certification. These records and documents include:

- 1. Surface Mining License No. SL-0607, effective through December 31, 2024.
- 2. Surface Mining Permit No. 77-SP-0061-E, issued by the Maryland Department of the Environment, Land Management Administration, effective through March 31, 2025.
- 3. State of Maryland, Department of the Environment, Air and Radiation Management Administration, Operating Permit No. 031-0528, effective through August 31, 2027, for a stone crushing and screening plant equipped with a wet suppression system and nine baghouses, one portable ready-mix concrete plant with baghouse, one 2.1 MMBtu/hr No. 2 fuel-oil fired water heater, one pugmill system, and one cement silo with pulse-jet dust collector.
- 4. Emissions Certification and Toxic Air Pollutants Emission Certification Reports for 2022 required under Operating Permit No. 031-0528.
- 5. General Water Discharge Permit 15MM: Discharges from Mineral Mines, Quarries, Borrow Pits and Concrete and Asphalt Plants (NPDES Permit No. MDG 491365) issued by MDE. The site registration number is 15-MM-1365 with an effective date on December 26, 2017, and extending until April 30. 2022.
- 6. NPDES Quarterly Discharge Reports for outfall 1 covering the period of October 1, 2022, through September 30, 2023.
- 7. Site plan map dated February 22, 2022.
- 8. Particulate Control Plan dated December 27, 2023.
- 9. Certificate of Insurance for general liability, automobile liability, and workers compensation and employer's liability for the period 10/1/23 through 10/1/24.
- 10. Performance Bond No. 929517725 in the sum of \$100,735.00 with the effective date January 6, 2024.
- 11. Montgomery County, Department of Permitting Services, Sediment Control Permit No. 203770, effective through August 1, 2024.
- 12. Seismograph Records including vibration and air blast measurements covering the period November 2022 through November 2023.
