Vehicle #1 was traveling N/B in the parking lot to the rear of 12060 Cherry Hill Rd. Vehicle #1 failed to remain on the roadway, driving onto a sidewalk and grass area, striking the pedestrian. Pedestrian transported to Shock Trauma where she was pronounced.
