CERTAIN HERBICIDE AGENTS (AGENT ORANGE)  
USED IN VIETNAM (01-09-1962 to 05-07-1975)  
AND IN KOREA-DMZ (April 1, 1968 to August 31, 1971)  
PER TITLE 38 CFR, 3.309 (e)

1. CHLORACNE or other acne form disease consistent with chloracne  
(must manifest to a degree of 10% within one year of exposure)
2. TYPE 2 DIABETES (also known as Type II diabetes mellitus or adult-onset diabetes)
3. ISCHEMIC HEART DISEASE
4. PARKINSON'S DISEASE
5. HODGKIN'S DISEASE
6. MULTIPLE MYELOMA
7. NON-HODGKIN'S LYMPHOMA
8. ACUTE AND SUBACUTE PERIPHERAL NEUROPATHY (Must  
manifest to a degree of 10% within one year of exposure)
9. PORPHYRIA CUTANEA TARADA-PCT (Must manifest to a degree  
of 10% within one year of exposure)
10. PROSTATE CANCER
11. RESPIRATORY CANCERS cancer of the lung, bronchus, larynx or trachea)
12. CHRONIC LYMPHOCYTIC LEUKEMIA-CLL

14. B CELL LEUKEMIAS, SUCH AS HAIRY CELL LEUKEMIA

15. SOFT-TISSUE SARCOMA (other than osteosarcoma, chondrosarcoma, Kaposi's sarcoma or mesothelioma) The term "soft-tissue sarcoma" includes the following:

- a. Adult fibrosarcoma
- b. Dermatofibrosarcoma protuberans
- c. Malignant fibrous histiocytoma
- d. Liposarcoma
- e. Leiomyosarcoma
- f. Epithelioid leiomyosarcoma (malignant leiomyosarcoma)
- g. Rhabdomyosarcoma
- h. Ectomesenchymoma
- i. Angiosarcoma (hemangiosarcoma and lymphangiosarcoma)
- j. Proliferating (systemic) antioendotheliomatosis
- k. Malignant glomus tumor
- l. Malignant hemangiopericytoma
- m. Synovial sarcoma (malignant synovioma)
- n. Malignant granular cell tumor of tendon sheath
- o. Malignant schwannoma, including malignant schwannoma with rhabdomyoblastic differentiation (malignant Triton tumor), glandular and epithelioid malignant schwannomas
- p. Malignant mesenchymoma
- q. Malignant granular cell tumor
- r. Alveolar soft part sarcoma
- s. Epithelioid sarcoma
- t. Clear cell sarcoma of tendons and aponeuroses
- u. Extraskkeletal Ewing's sarcoma
- v. Congenital and infantile fibrosarcoma
- w. Malignant ganglioneuroma

All Vietnam veterans are encouraged to obtain an application for the free Agent Orange Protocol Examination at the nearest VA Medical Center. A copy of DD 214, Military Separation document from active duty, must be attached to application.
