The Montgomery County Council is the legislative branch of County Government. Individual Councilmembers introduce bills based on their own experience with community problems or because they have been approached by a constituent or group of constituents. Legislation enacted by the Council is delivered to the County Executive, who has 10 days to approve or disapprove it. If the Executive vetoes the bill, the Council has 60 days to reenact it over the Executive's veto by the vote of 6 members. In the case of emergency legislation necessary for the immediate protection of public health or safety, notice of public hearing may be given by press release. Six votes are required to enact an Emergency bill. Emergency legislation takes effect immediately; regular legislation takes effect 91 days after enactment. View live house floor proceedings via their website. As per the Constitution, the U.S. House of Representatives makes and passes federal laws. The House is one of Congress's two chambers (the other is the U.S. Senate), and part of the federal government's legislative branch. The number of voting representatives in the House is fixed by law at no more than 435, proportionally representing the population of the 50 states.
