- I. Welcome The meeting opened by Kevin Redden, Chair of the Montgomery County Commission on Juvenile Justice (CJJ). Kevin introduced Elizabeth Emen as the new ex officio member from Health and Human Services.
- **II. Attendance** After taking attendance, Diane Lininger asked everyone to mute their microphones unless they were speaking.

- **III. Speaker:** Alycia Chuney, Project Director for Young Adult Programs, Collaboration Council for Children, Youth and Families. Alycia works with all projects for young adults (16 to 24 years old) through the Collaboration Council. Alycia will discuss the three programs she oversees.
 - A. MoCo Drop-In Center (Wheaton) (part of Montgomery Reconnect)
 - The Drop-In Center opened last year.
 - The purpose is to work with young people disconnected from school and/or experiencing homelessness.
 - Three providers in this space:
 - B. Shephard Pratt (Provides therapy on site)
 - LGTBQ navigation
 - Pride Youth Services (which provides the AMEN program which is a 12-week curriculum that supports growth/leadership of young men).
 - Latin American Youth Center (GED Program has about thirty students ages 16-24). Can take referrals for students who are not close to Wheaton – can take the program remotely. Also provides Case Management Services.
 - C. Conservation Corps Allows young people to earn GED while working at the same time.
 - Once youth are done with the program, staff try to then connect them to employment.
 - D. Evening Reporting Center (another program) (located in Rockville)
 - For young people who have touched the Department of Juvenile Services system. This is a program for young men and women, but the individuals in the program are overwhelmingly male.
 - If the court approves, they can bypass the detention center and report to the reporting center.
 - Work on mindfulness and restorative practices
 - Once complete, they do not have to report to a detention center.
 - Youth are referred to the program by DJS.
 - Will have summer programming as well (internships, etc)
 - Funding is a mix of public and private.
 - Alycia will share information with Diane about how to connect young people to the program.
- IV. Discussion May meeting and topics for the Circuit Court Judges
 - Diane circulated last year's topics/questions for reference (Diane shared the questions via share screen)
 - Kevin would like the judges to discuss their thoughts on legislative changes on juvenile justice.
 - Carol would like to hear judges' thoughts on automatic charging. What
 factors are most significant in determining that a child needs to be waived
 up to adult court what are key factors judges look to? Should automatic
 charging be repealed, interested in the challenges prosecutors will face
 establishing that case should be in adult court what kind of evidence will
 prosecutors need?

- Melissa would like their opinion on whether all children should start in juvenile court, rather than adult court.
- Carlotta: which judges are coming because some judges/magistrates do
 not hear these waiver matters we should tailor our questions to the judges
 who will be present.
- Brett: Judge Smith will be the best judge to discuss waiver/transfer.
- Steve Neff: wants to know what judges are seeing regarding fentanyl cases, and whether they see these matters as different than other drug cases.
- Diane asks that we send any questions we propose to her by next week, so that she can get them to the judges at least one week prior to the meeting.
