- **I. Welcome** Chair, Christopher Jennison, welcomed members, called meeting to order, and communicate the goals of the meeting to present members and guests.
- **II. Attendance** Diane took attendance and asked all attendees to mute microphones unless speaking.
- III. Speaker Julia Angel, Senior at Richard Montgomery High School. Young People for Progress's teach-in on policing in schools and Lead Organizers of MoCo Against Brutality

(Use of clinical social workers in MCPS) Clinical social worker model aims to integrate learning supports instruction, school management and facilitate

multidisciplinary collaboration. It also allows for flexible use of funding and education, mental health services.

- Team-based framework to help facilitate effective coordination of services during a crisis.
- Begins with proactive leadership.
- Reduce police presence in schools, and use other role models, other adults, and other qualified mental health support workers
- More effective & healthier way for students to communicate and resolve issues
- Licensed clinical social workers can develop staff and service training, programs, assist with behavior management
- Support, parents and families
- Move away from policing and punitive discipline.
- Interrupts the school to prison pipeline

Active problem: SROs do not promote a culture of Restorative Justice and instead criminalize students

#### What MCPS lacks:

- Strong RJ culture
- \*Not much change seen from SRO to CRO change
- RP data not collected; implementation varies from school to school.
- \*Doesn't believe most students are aware of the mental health professionals in the school

Speaker: Shauna-Kay Jorandby: Director, Student Engagement, Behavioral Health & Academics – to discuss the MOU between MCPS and Restorative Justice in MCPS.

- Hiring of mental health professionals was reduced from 50 to 33 to use the same funding to extend salary to 12-month salaries
- Includes one social worker supervisor: really important in building a career ladder to having future social workers
- Can also take LMSWs or LGSWs; licensed master's social workers, who are earning their clinical licensure; broaden the number of mental health supports and professionals that they can hire.
- Take on interns (25 spaces)
- Social workers receive Restorative Justice (RJ) training. Several of them have already attended IIRP, which is a restorative justice institution (Bethlehem, Pa.)
- They will also be responsible for divergent services for court involved youth as a part of their caseload.
- RJ is something that implementation takes time. Studies that you look at; some say from 3-5 years, recent ones say up to 10 years: deep level implementation of this cultural shift.
