- **I. Welcome** Chris Jennison, Chair, introduced the judges at 7:05pm. Briefly discussed the Teams platform and how to ask questions.

- **III. Speaker: Carlotta Woodward,** Chief Juvenile Court Division, Montgomery County States Attorney Office spoke on criminal justice reforms in Maryland including:
- 2020 Legislative Session Ms. Woodward provided an overview of the variety of juvenile related bills that were passed during the 2020 legislative session as well as the numerous bills that were not passed. The "Child Interrogation Protection" bill <u>SB0593/HB0624</u> which did not pass was of particular interest to commission members.
- Teen Court & Diversion Montgomery County does have a Juvenile Diversion Program that is a multi-agency program with a mission is to divert first and second time misdemeanor offenders. Program involves multiple levels including assessment by a licensed clinical social worker, SASCA, Teen Court, Truancy Prevention, etc. Teen court is suspended currently due to COVID-19. The Truancy Prevention program is suspended for Fall 2020 due

to COVID-19 but the program is slated to resume when schools resume in-person operations.

 Drug Court for Juveniles – Montgomery County does not currently have a juvenile drug court. There was a previous attempt to implement a juvenile drug court over a decade ago however it was not successful and any future implementation would require significant consideration to ensure it was appropriate/successful for juveniles.

- b. Report on Montgomery County Youth Town Hall Francha Davis
 - a. County Council Members and Montgomery County Recreation Department hosted a town hall on 6/17 to provide a space for youth voices to discuss topics including youth's experiences of racism and contact with police in the schools. The town hall was a success and there may be future town halls conducted as well.
- c. Detention Updates (re: COVID) Commission members asked for updates if available on how youth in detentions are faring during the pandemic. Public Defenders Rep shared that youth have been experiencing disrupted education as well as very restricted visitation with few to no in-person visitations occurring. DJS Rep provided an updated that detention centers are allowing visitations when possible but this varies by facilities and may be impacted by youth or staff testing positive at any time. DJS Rep encouraged commission members to reference the DJS website for specific COVID related updates.
