- **I. Welcome** Chair, Christopher Jennison, welcomed members, called meeting to order, and communicated goals of the meeting to present members and guests.
- **II. Attendance** Diane took attendance and asked all attendees to mute microphones unless speaking.
- III. Speaker: Antonia McCloud, Superintendent Alfred D. Noyes Children's Center.
 - **a.** The Alfred D. Noyes Children's Center is presently managed and operated by a full staff.
 - **b.** Occupancy during the pandemic was as low as 8-9 youth whereas prior to the pandemic, the Center housed 16-20 youth.
 - **c.** Family member visitation was recently re-instated to seven days a week. Visitation, supervised by two Noyes staff members, is now available in-

- person or virtually. Except for inclement weather, residents have in-person visitations outdoors.
- **d.** Recreation staff provides a variety of activities promoting physical health and wellness. Volunteers can now report back into the Center to assist with recreational activities.
- **e.** Noyes is now administering COVID-19 vaccinations. However, youth under 18 years old must receive a signed consent from guardians.
- f. Noyes has a quarantine unit for new residents upon their initial entry to the Center.
- **g.** The mental health staff was instrumental in working with the youth during the pandemic.
- **h.** In the past, Commissioners dropped off donations of supplies, which can now resume.
- i. There have been no issues or concerns with the LGBTQ residents since the pandemic.
- **j.** There have been no issues with gang activities this year.
- **k.** Alfred D. Noyes Children's Center received a recent audit. The results indicate Noyes is operating effectively and in accordance with policies and select areas deemed critical to its protocols.
- I. The Commission will set up a time to tour the Alfred D. Noyes Children's Center this year.

V. New Business

- a. Nomination Committee Patty Lyman presented the nomination slate for FY-22. Chris Jennison, Chair, Tracey Friedlander Vice-Chair and Francha Davis for Legislative committee chair. The proposed schedule received a vote and received favorable approval by Commission members.
- **b.** July meeting coming up with priorities and subcommittees for the year. Diane will send out Annual work-plan and budget priorities for the Commissioners to review prior to the meeting.
- **c.** Committee members should contact Chris or Diane if they would like to submit an article about our meeting with the judges for the annual report.
- **d.** The Program Manager has released vacancy notices for new commissioners. Please inform Diane if you are interested in serving as a CJJ interviewee panel member.
- **e.** The May 2021 meeting minutes have not finalized and will require a vote during the CJJ July meeting.
