- I. Welcome Chair, Christopher Jennison, welcomed members, called meeting to order, and communicated goals of the meeting to present members and guests.
- **II. Attendance –** Diane took attendance, and requested that attendees muted microphone unless speaking.
- III. Speaker Dr. Rolando Santiago, Chief of Behavioral Health and Crisis Services - speaking on Strategic Planning for Behavioral Health and Crisis Services. Strategic planning utilized the *appreciative inquiry* process here in the County (pre-pandemic) to develop framework and how to implement it. This resulted in the strategic plan document with 4 pillars:
 - <u>Promotion</u> promote healthy practices by educating, promoting appropriate mental health practices that keep people healthy and free from substance use (or with alternatives)
 - <u>Prevention</u> create targeted programs and interventions that prevent substance use and mental health issues (example here in the county – positive youth development)
 - o <u>*Treatment*</u> many of our existing programs are in the treatment pillar
 - <u>Recovery</u> programs that lead/support the recovery process
 - Crisis Now Model

- o Sponsored by National Association of Mental Health Directors
- SAMSHA has a similar document
- Four components:
 - Integrated call center
 - Crisis outreach teams
 - Stabilization center
 - Crisis care follow up
- Envision a crisis response similar to a traffic control tower that is managing hundreds/thousands of airplanes at the same time.
- Ultimate goal divert people from being incarcerated or being admitted at emergency rooms.
