- I. Welcome Chair, Christopher Jennison, welcomed members, called meeting to order, and communicate the goals of the meeting to present members and guests.
- **II.** Attendance Diane took attendance and asked all attendees to mute microphones unless speaking.
- **III. Speaker -** Nathanial T. Parks, DHHS, re: Plum Garden Shootings PowerPoint emailed out
 - Collaboration by agencies and individuals, including families involved in incident; Eco mapping of those involved, and releases signed by families
 - The team wanted to make sure they did not cause any further violent incidents
 - Conflict was brewing in community before shooting.

- Presentation by Sharon Lemone, DHHS
 - Assigned the accused shooter's family, interacted with his mother who was very willing to work with DHHS
 - Family was quickly moved out of Seneca Ridge community into temp housing in a hotel
 - What could have been done better
- Ellen O'Connel, DHHS
 - How got to collaboration
 - Wrap around collaboration with MCPS, DHHS, etc.
 - Team took accountability if things went wrong. The collaboration took them out of isolation of school PPW standpoint into working collaboratively to help family
- Katherine Smithson, Identity
 - o Worked with family of person who lost their life
 - Provides intensive case mgt to families or cases that require relocation
- Toriano Cross, DHHS
 - o Process is important, immediate answers are not always possible
 - "The Ridge Boys", others involved
 - "Band Up" group
 - o Still working with families
- Nathaniel Parks, CWS
 - o 3 families relocated, 2 permanently
 - \circ $\;$ Kids back in school because of collaboration
- Questions
 - Carlotta Woodward, States Attorneys' Office: indicated she is a prosecutor on the case and made her presence known to speakers
 - Frank Duncan, Department of Juvenile Services: These are informal cases, should they be crossover cases with DJS? One child was involved with CWS case, was a victim. That is why it was not a crossover
 - Carol Cichowski, Citizen Commissioner: What other incidents would trigger this type of response? Actively spilling conflict, DHS, school, etc. Wanted to be across systems to address violence
 - Magruder shooting also triggered a crisis response, collaborated
 - PowerPoint requested
 - Donald Chisholm, Citizen Commissioner: How does DHHS characterize social media in this circumstance? Good and bad, helps get information about individuals involved. Threats shared with MCP. Able to engage families on social media.
 - Sharon Lemone: social media comment. The alleged shooter's family went back into old community and there was another shooting. But mother then realized to get mental health services for herself and her children.
 - Eddie Ellis, Citizen Commissioner: utilizing people in communities that have past criminal issues but changed their life, for the children to look up to? Yes. Also, Toriano Cross is in this position. Also provide guest speakers, i.e. at Clarksburg jail. Also use vendor for county to help. They have individual community connections.
