- **I. Welcome** Chair, Christopher Jennison, welcomed members, called meeting to order, and communicated goals of the meeting to present members and guests.
- **II. Attendance** Diane took attendance and asked all attendees to mute microphones unless speaking.
- III. Speakers: State of Maryland Delegate Sandy Bartlett and James L. Dold, J.D., CEO & Founder of Human Rights for Kids. To discuss Juvenile Interrogation Protection Act and how the Commission on Juvenile Justice can assist in getting bill passed this year. Also, a discussion on upcoming Juvenile Justice legislation.

- CJJ helped by penning op-eds in Maryland Matters to discuss the topics of the bills and expressing those viewpoints for change.
- Article 37 of the UN Convention on the rights of the child which the US is not ratified but specifically states that at the point that criminal legal proceedings begin, ie., when a child is arrested, they are to be afforded access to prompt legal assistance and that does not happen in the state of Maryland.
- "Black and brown lives don't matter until black and brown children lives matter. In the black lives of children cannot matter unless we're willing to protect their basic human rights."
- Justice Reform Council will submit supplemental reports on its findings and recommendations, but it will not come in at the deadline, but reports are available on the Maryland Department of Legislative Services site.
- Minimum age will continue to be looked in bills to be pushed, but the big argument is, when does a child's brain develop enough to the point where we are going to hold them accountable in the legal system?
- Bartlett: Believes schools do need the conflict resolution vessel; restorative justice, and need some SROs available in schools, but need to continue to train them in their capacity of what they can do is not finite. Does not believe the solution is to rid of all SROs.
