Dr. Haller has been with the Commission since 2003. He served two full terms and has been an emeritus member since 2009. Dr. Haller has been an influential member of the Commission. He has provided us with numerous educational materials and was one of the major players in helping to write the legislation for competency for youth. The Commission along with other legislators wrote the law and Commission members were strong advocates for its passing. Dr. Haller has made Montgomery County a better place for our youth.

- **III. Speaker:** Crystal N. Brice, Field Director, Instruction & School Support, DCCR-Juvenile Services Education, Maryland State Department of Education to update us on how the educational system is working in the juvenile detention facilities.
  - Has a goal of providing juveniles with education that allows them to be certified within various industries or trade.
  - There is an initiative to provide students with I-pads, teachers have access to I-pads.
  - DJS provides interpreters for Spanish speaking students.
  - Students are now only receiving 1/2 credit or a whole credit (this allows them to transfer credits)
  - Juveniles take GED ready test online
  - DJS is working on a Memorandum of Understanding with community colleges so juveniles can attend once they leave the DJS system.
