- **III. Speaker** Judge <u>Marielsa Bernard</u> spoke about concerns of juveniles and young adults involved in the criminal justice system. - Janet Reno said, "unless we understand the effect of substandard housing poor education indifference or children poverty police brutality all of these factors and others in effect of these will be in violence again."
- "There is a report that came out of the Justice Policy Institute that spoke about Maryland's data that said that even though people of color made up only 31% of Maryland's population they constitute more than 70% state prison population percent of those in local jails."
- Most people don't understand the multiple issues that are faced daily by many members of our community, especially children and youth of color. difficulties that youth of color deal with daily and the trauma they've experienced.
- It hurts when judicial system fails our youth. "So, in my view that's a failure
 of our system, even after a juvenile case has been closed supposedly
 successfully, I often hear that they've picked up adult charges or even
 worse."
- Re-Entry programs and services needs more attention in Montgomery County
- "Childhood adversity contributes to most of our major chronic physical and mental health issues as well as economic and social health issues."
- The development of a countywide ACEs resilience initiative is especially important.
- Work group hopes to implement requirements for Circuit Court all presentence reports in adult criminal matters as well as reports in juvenile court provide information about parental incarceration. Determining if a defendant or juvenile respondent has a child must be considered in making a final determination.
- Wants to bring more successful initiatives to Montgomery County found in other counties like Prince Georges and Frederick. Examples: Adam's House (1-stop shop for males/fathers,) and Handle with Care Initiative.
