<u>FOOD – YEAR ROUND LICENSE</u>	
Type A Facility - Low Priority (Facilities that serve commercially packaged potentially hazardous foods directly to the consumer; or non-potentially hazardous food that is cut, assembled, or packaged on the premises, such as candy, popcorn, and baked goods; or hand dipped ice cream) - Annual License	\$200
Type B Facility - Moderate Priority (Facilities that serve potentially hazardous food that is prepared requiring the food to pass through the temperature danger zone, 41°F to 135°F, one time before service, such as cooking, hot holding, and then serving; or facilities that cut, assemble, or package on the premises, such as meats) - Annual License	\$375

Type C Facility - High Priority (Facilities that serve potentially hazardous food that is prepared a day or more in advance of service; or using food preparation methods that require the food to pass through the temperature danger zone, 41°F to 135°F, two or more times before service, such as cooking, cooling, and then reheating) – Annual License	\$525

Non-profit charitable organization - Annual License	\$100
Non-profit organization operating for 14 consecutive days or less selling potentially hazardous food - Temporary License	\$30
Non-profit organization operating for 14 consecutive days or less selling non-hazardous food - Temporary License	\$15
