Call to order–Chair, Noelle Heyman called the meeting to order at 9:30 am.

Welcome and Introductions–Noelle welcomed all attendees. Staff and guest introduced themselves.

Action–Approval of March 23, 2017 full Commission minutes were approved unanimously.

Treasurer's Report–Treasurer Revathi Vikram reported that the COA account balance is \$ 6,380.82.

MNCPPS Senior Housing Study—Gwen Wright from the Montgomery County Planning Office heard from Aging in Place Committee about the concerns and challenges with the Rental Housing Study that is being conducting in conjunction with the Department of Housing and Community Affairs. Ms. Wright sent a letter to the COA addressing some of the questions asked by Aging in Place Committee (AIPC). Montgomery County Planning Office is conducting a senior housing study and is inviting COA participation.

Affordable Senior Housing Roundtable Discussion—moderated by Leslie Marks. Guest speakers include: Doris Gantos, Senior VP Bozzuto, Robert Goldman, CEO Montgomery Housing Partnership and Alan Goldstein, AHC Inc. The population in Montgomery County is over a million people. It is projected in 2040 there will be more seniors ages 65 and over in Montgomery County than school age children. According to County Stat 61% of renters in Montgomery County are housing burdened which mean people are paying over 30% of their income for housing.

Robert Goldman, President of Montgomery Housing Partnership. Robert Goldman has been President of Montgomery Housing Partnership (MHP) for the past 13 years and has also worked in housing policy on both the federal and local levels. MHP creates quality affordable homes. It accomplishes its affordable housing mission by housing people, empowering families, and strengthening neighborhoods. Formed in 1989 as a 501(c)(3) to meet Montgomery County's growing need for affordable housing, MHP builds, acquires and rehabilitates apartments, condos and homes for low- and moderate-income families. Through its affiliates, MHP has developed more than 1,400 apartments, condos, and townhomes around the county, including in transit-oriented neighborhoods in Silver Spring, Takoma Park, Rockville, and Wheaton.

MHP's holistic approach to housing includes providing affordable rents, developing educational programs for residents and implementing neighborhood revitalization efforts in communities impacted by foreclosures and the economic downturn.

Montgomery Housing Partnership's mission is to preserve and expand quality affordable housing in Montgomery County. They advance their mission through three key strategies:

- 1. Housing People by acquiring, rehabilitating, building and managing quality affordable housing
- 2. *Empowering Families* by developing and implementing community life programs to improve the quality of life and increase opportunities for Montgomery County residents.
- 3. Strengthening Neighborhoods by collaborating with concerned citizens and businesses, public officials and community organizations to build strong, vital neighborhoods.

Area Agency on Aging (AAA)– Dr. Odile Brunetto reported that the County Council has added to their wish list in addition to Mr. Leggett's FY18 budget the following:

- Full-time position for Public Guardianship Program.
- \$150,000 for a Senior Center Plus Program in partnership with Department of Recreation.

Dementia Friendly America are putting together a Speaker Bureau to go to various businesses in the County to promote Dementia Friendly. There will be a kickoff event on June 21st at 10am the location will be announced at a later time.

Age Friendly Montgomery County Advisory Group met on April 26th. There was a presentation from Janine Tursini, Executive Director for Arts for the Aging. (AFTA). Ms. Tursini spoke to the audience about their vision and to promote how important dignity and compassion are in the care of older adults.

On the federal level, Administration on Aging is preparing for a 16% reduction. The impact of this funding reduction would be felt most severely in meals programs, the senior employment program and the senior health insurance program—the last two are proposed for elimination.

During the discussion at the HHS Committee meeting, Councilmember Roger Berliner proposed \$5,400 for one time funding to developing a toolkit that will explain to caregivers the challenges of hiring caregivers privately compared to hiring caregivers through an agency.
