DESCRIPTION

This project provides for the placement of a large designated child-care classroom at public schools where Montgomery County Public Schools (MCPS) is undertaking major construction or renovation. MCPS will oversee the construction or renovation of the school, and the county will arrange to lease the child care portion of the building to a private child-care provider. Cost estimates are based on per square foot costs for elementary school construction, and adjusted by the additional State licensing requirements for child care, related to restroom and food preparation facilities. Site specific factors are not included.

COST CHANGE

Net decrease due to additional site development and equipment costs for the Takoma Park Elementary School Child Care Center being offset by lower than projected costs for the center at Galway Elementary School. The construction costs for child care centers at Weller Road and Bel Pre previously included in the "Beyond 6 Years Column" in the FY07-12 Amended Project, have now shifted into the FY09-14 expenditure schedule. These costs are based on square footage estimates only.

JUSTIFICATION

"Child Care Modular Study" (1989); "Report of the Interagency Committee on Child Care Facilities at Public School Sites" (1989) established the policy of locating child day care facilities at school sites.

FISCAL NOTE

Galway ES Child Care Center is currently in the construction phase with the expected completion in 2008. Takoma Park ES will be in the construction phase in FY09, with the expected completion in FY10. Project costs for child care centers at Weller Road and Bel Pre Elementary Schools are currently estimated at \$1.012 million, with revised cost estimates expected following the facility planning process. Planning and design for Weller Road and Bel Pre are scheduled to begin in FY10 and FY11 respectively.
