# **Legislative Oversight**

## MISSION STATEMENT

The mission of the Office of Legislative Oversight is to determine the effectiveness of legislation enacted by the County Council, and to make findings and recommendations concerning the performance, management, and operation of programs and functions for which funds are appropriated or approved by the Council.

#### **BUDGET OVERVIEW**

The total approved FY13 Operating Budget for the Office of Legislative Oversight is \$1,331,137, an increase of \$102,277 or 8.3 percent from the FY12 Approved Budget of \$1,228,860. Personnel Costs comprise 97.0 percent of the budget for eight full-time positions and three part-time positions for 10.30 FTEs. Operating Expenses account for the remaining 3.0 percent of the FY13 budget.

OLO studies the effectiveness of legislation enacted by the Council and makes findings and recommendations concerning the performance, management, and operation of programs and functions for which funds are approved or appropriated by the Council. OLO is also the designated administrator for the Council's audit contracts, as required under Section 315 of the County Charter.
