PROJECT DESCRIPTION

William H. Farquhar was built in 1968. Scheduling of this modernization is consistent with the MCPS long-range plans to renew aging facilities on a rational and periodic basis. The modernization will include an addition to this facility due to projected enrollment growth. Due to fiscal constraints, the modernization schedule for elementary, middle, and high schools was delayed. Planning funds for this project were approved in FY 2012. Due to fiscal constraints, middle school modernizations were delayed in the adopted FY 2013-2018 CIP. An FY 2015 appropriation was approved for construction funds. An FY 2016 appropriation was approved to complete this project. This modernization is scheduled to be completed by August 2016.
